TAXES - LIENS - INSURANCE - MAINTENANCE - I will pay, when they are due and payable, all taxes, lient, a assessments, obligations, water rates and any other charges against the Property, whether superior or inferior to the lien of this mortgage, maintain hazard insurance on the Property in your favor in a form and amount satisfactory to you are: maintain and keep the Property in good repair at all threes during the term of this medicage.
