#### THE COVENANTS. CONDITIONS AND PROVISIONS PREVIOUSLY REFERRED TO ARE:

- 1. Promises of Borrower -- Borrower represents and warrants that:
  - Borrower owns the Property;
  - Borrower has the right to mortgage, grant, and convey the Property to Trustee; and
  - c. There are no claims or charges outstanding against the Property except any mortgages or trust deeds that are currently shown in the office where real estate records are filed for the County where the Property is located.

Botrower gives a general warranty of title to Trustee on behalf of the Holder of the Note. This means that Borrower will be fully responsible for any losses which Trustee on behalf of the Holder of the Note suffers because someone other than Borrower has some of the rights in the Property that Borrower represents and warrants to have. Borrower will defend ownership of the Property against any claims of such rights.

- 2. Borrower's Promise to Pay The Agreement. Borrower promises to promptly pay all amounts due on the Agreement except as explained in no agraph 9.
- 3. Borrower's Promise to Pay Charges and Assessments. Borrower promises to pay all present and future liens, taxes, assessments, utility bills, and other charges on the Property, including any amounts on any prior mortgage or trust deed, as they become due.
- 4. Borrower's Promise to Buy Haard Insurance. Borrower promises to obtain a hazard insurance policy payable to Trustee for the benefit of the Holder of the Mote, and which covers all buildings on the Property. The insurance must be satisfactory to the Holder of the Note and must cover loss or damage caused by fire and hazards normally covered by "extended coverage" hazard insurance policies. The insurance must be in the amounts and for the periods of time required by the Holder of the Note. Borrower will notify the Holder of the Note promptly if there is any less or damage to the Property. The Trustee or Holder of the Note may files "Proof of Loss" form with the insurance company. Borrower directs the insurance company to pay all "proceeds" to Trustee for the benefit of the Holder of the Note. "Proceeds" are any money that the insurance company owes to the Borrower under the policy. Unless the Holder of the Note agrees in writing that the Proceeds can be used differently, the Proceeds will be applied to pay the amount Borrower owas the Holder of the Note.

If any Proceeds are used to reduce the amount which Borrower twee the Holder of the Note under the Agreement, Borrower will still have to make the regular payments under the Agreement until the entire amount Borrower owes is paid in full. If Trustee forecloses this Trust Deed on behalf of the Holder or the Note, anyone who buys the Property at the foreclosure sale will have all the rights under the insurance policy.

- 5. Berrower's Promise to Buy Flood Insurance. If the Land or any part of the Land is located in a designated official flood-hazard area, Borrower promises to buy flood insurance in the maximum amount available or the amount secured by this Trust Deed, whichever is less. Borrower agrees to direct that any money payable under the flood insurance will be paid to FA Trustee on behalf of the Holder of the Note, but Borrower will still have to make regular payments under the Agreement until the entire amount Borrower owes is paid in full.
- 6. Borrower's Promise to Maintain and Repair the Property. Borrowers shall (a) promptly repair, restore and rebuild any buildings or improvements now or hereafter on the Property which may become damaged or be described; (b) keep said Property in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien not expressly subordinated to the lien hereof; (c) pay when due any indebtedness which may be secured by a lien or charge on the Property superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to Holder of the Note, (d) complete within a reasonable time any building or buildings new or at any time in process of eraction upon said Property; (a) comply with all requirements of law or municipal ordinances with respect to the Property and the use thereof; (f) make no material alterations in said Property except as required by law or municipal ordinance.
- 7. Trustee/Holder of the Note Right to Take Action to Protect the Property. If (1) Borrower does not keep Borrower's promises and agreements made in this Trust Deed, or (2) someone (Borrower or anyone class) begins a legal proceeding that may significantly affect Trustee's or the Holder of the Note's rights in the Property (such as, for example, a legal proceeding in bankruptcy, or to condemn the Property), then Trustee or the Holder of the Note may do and pay for whatever is necessary to protect the value of the Property and the rights of Trustee or the Holder of the Note in the Property. Actions of the Trustee or the Holder of the Note under this section may include, for example, paying any amount due under any prior mortgage or trust deed, appearing in court, paying reasonable attorneys' fees, and enturing on the Property to make repairs.

Proporty or Coot County Clert's Office

Borrower promises to pay Trustee or the Holder of the Note all amounts that either Trustee or Holder of the Note pays under this section. If Trustee and/or Holder of the Note pays an obligation, Trustee and/or Holder of the Note will have all of the rights that the person paid by Trustee or the Holder of the Note would have had against Borrower. This Trust Deed covers all these amounts that Trustee or Holder of the Note pays, plus interest, at the rate that is figured as if the money had been given under the Agreement, or if that rate violates the law, then at the highest rate that the law allows. This Trust Deed also covers reasonable compensation to Trustee for each matter concerning which action herein authorized may be taken.

If Borrower fails to maintain insurance on the Property as required in paragraphs 4 or 5, the Trustee or the Holder of the Note may purchase insurance on the Property, without notice to Borrower and charge Borrower for the cost as provided in this Trust Deed. If the Trustee or the Holder of the Note purchases this insurance, it will have the right to select the agent. Any hazard insurance and/or flood insurance purchased by the Trustee or Holder of the Note on the Property may be limited to the amount due under the Agreement at the time the insurance is purchased, even if the Property is worth more. The Trustee or the Holder of the Note is not required to obtain the lowest cost insurance that might be available.

- 6. Rights of the Trustee and Holder of the Note. Any failure or delay by the Trustee or the Holder of the Note in enforcing the rights available to them in this Trust Doed or the law, will not cause the Trustee or Holder of the Note to give up those rights. The Trustee or Holder of the Note may exercise and enforce any of its rights until its rights under the Trust Doed end. Each right that this Trust Doed gives to the Trustee or the Holder of the Note is separate. The Trustee or Holder of the Note may enforce and exercise them one at a time or all at once.
- 9. Joint Borrowers. Each person that signs this Trust Deed is responsible for keeping all of the promises made by the Borrower. Trustee or Holder of the Note may choose to enforce their rights against anyone signing the Trust Deed as an individual or against all of them. However, it someone signed this Trust Deed, but did not sign the Agreement, then that person will not be required to pay any amount under the Agreement, but will have signed only to give Trustee or Holder of the Note the rights that person has in the Property under the terms of this Trust Deed.
- 10. Selling the Property. Borrower agrees not to sell or transfer all or any part of the Property, or any rights in the Property, including the sale or transfer of the beneficial ownership in the Property where Borrower is a Land Trust, without the written consent of the Holder of the Note. This includes sale by Contract for Dued
- 11. No Defaults Under Prior Mortgages. If there is already a mortgage or deed of trust against the Property, the Borrower promises that there will never be a default under that mortgage or deed of Lust.
- 12. Request for Notice of Default and Foreclosure. Borrower and Trustee, on totalf of the Holder of the Note request the holder of any mortgage, deed of trust or other encumbrance with a lien which has priority over this Trust Deed to give Notice to Trustee, at Trustee's address set forth on page one of this Trust Deed, of any default under the superior encumbrance and of any sale or other foreclosure action.
- 13. No Other Mortgages or Deed of Trust. Borrower agrees not to mortgage or encumber by a feed of trust all or any part of the Property or allow anyone class to have a lien on the Property without the Holder of the Note 5 written consent.
- 14. Trustee/Holder of the Note -- Remidies and Foreclosure. If Trustee or Holder of the Note require Morrower to pay the entire outstanding balance under the Agreement in one payment (called "ecceleration") and Horrower fails to make the payment when due, then Holder of the Note or Trustee may foreclose this Trust Deed as provided below. However, before accelerating, the Trustee or the Holder of the Note will send Borrower a written notice by certified mail which states:
  - a. The promise that Borrower failed to keep or the representation or warranty that Borrower breached;
  - b. The section Borrower most take to correct that failure;
  - c. The date, at least 30 days away, by which the failure must be corrected;
- d. That if Borrower doesn't correct the failure or the representation or warranty that Borrower breached, Trustee or Holder of the Note will accelerate, and if Borrower doesn't pay, Trustee or another person may buy the Property at a foreclosure sale:
  - e. That Illinois law allows Borrower to reinstate the Trust Deed after acceleration; and
- f. That Borrower may bring suit in court to argue that all promites were kept and to present any other defenses Borrower has to acceleration.

Trustee or successor trustee shall be entitled to reasonable companisation for any other act or service performed under any provisions of this Trust Deed.

Trustee or Holder of the Note need not send the notice if the promise Borrower failed to keep consists of Borrower's sale or transfer of all or a part of the Property or any rights in the Property without the written consent of the Holder of the Note. If borrower does not correct the failure by the date stated in the notice, Trustee or Holder of the Note may accelerate. If Trustee or Holder of the Note accelerates, Trustee or Holder of the Note may foreclose this Trust Deed according to the Illinois Statues. Borrower give Trustee/Holder of the Note a power to sell the Property at a public auction. The proceeds of any foreclosure sale of the property shall be distributed and applied in the following order of priority: First, on account of all costs and expenses incident to the foreclosure proceedings, including all such items as are mentioned in the preceding paragraph hereof; second, all other items which under the terms hereof constitute secured indebtedness additional to that evidenced by the Agreement with interest thereon as herein provided; third, all principal and interest remaining unpaid on the Agreement; fourth, any overplus to Borrower, their heirs, legal representatives or assigns, as their rights may appear.

15. Appointment of Reviver. Upon, or at any time after the filing of a bill to foreclose this Trust Deed, the court in which such bill is filed may appoint. receiver of said Property. Such appointment may be made either before or after sale, without notice, without regard to the solverey or insolvency of the Borrower at the time of application for such receiver and without regard to the time value of the Property or whether the same shall be then occupied as a homestead or not and the Trustee bereunder may be appointed as such receiver. Such receiver shall have the power to collect the rents, issues and profits of said property during the pandancy of such foreclosure suit and, in case of a sale and a deficiency, during the full statutory period of redemption, whether there be redemption or not, as well as during any further times when Borrower, except for the intervention of such receiver, would be entitled to collect such reads, issues and profits, and all other powers which may be necessary or are usual in such cases for the property during the whole of said period.

The Court from time to time may authorize the receiver to apply the net income in his hands in payment in whole or in part of: (a) The indebtedness secured hereby, or by any decree re-reclosing this Trust Deed, or any tax, special assessment or other lien which may be or become superior to the lien hereof or of such decree, provided such application is made prior to foreclosure sate and (b) the deficiency in case of sale and deficiency.
