THAT, WHEREAS, the Mortgagors are justly indebted to the Mortgagee upon a Mortgage Note of even data herewith, and on extensions and ranewals in the initial principal sum of Eleven Thousand Two Hundred Sixty and 00/100-DOLLARS (\$11,260.00), and for advances, if any, not to exceed Five Thousand Dollars (\$5,000), payable to the order of and delivered to the Mortgagee, in and by which Mortgage Note the Mortgagors promise to pay the said principal sum under the terms and conditions specified therein; within a payment of zero percent (0%) of the principal advances, if any, on the sale or transfer of the property or if the property that is the subject of this Mortgage is no longer the Mortgagors' principal place of residence and all of said principal are made payable at such place as the holders of the Mortgage Note may from time to time, in writing appoint, and in absence of such appointment, then at the office of the Mortgages at Village of Streamwood, 301 East Irving Park Road, Streamwood, IL 60107.

## UNOFFICIAL COPY THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 2

- 1. Prompt Payment. Mortgagors shall promptly pay when due the principal indebtedness evidenced by the Mortgage Note.
- 2. Advances. Any and all advances or payments made by the Mortgagee hereunder shall be secured by this Mortgage pursuant to paragraph 3 of the Single-Family Rehabilitation Program Owners Participation Agreement.
- 3. **Performance of Mortgagors' Obligations.** Mortgagors shall perform all Mortgagor's obligations under any Mortgage, deed of trust or other security over this Mortgage, including Mortgagor's covenants to make payments when due.
- 4. Repair and Maintenance of Mortgaged Property. Mortgagors shall (1) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or destroyed; (2) keep said premises in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien not expressly subordinate to a lien hereof; (3) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof other than the prior mortgage referred to on Page 2 of the Mortgage, and upon request exhibit satisfactory evidence of the discharge of any such prior lien to the Mortgagee; (4) complete on or before the construction deadline contained in the construction contract for the project any building or buildings now or at any time in process of erection, construction, alteration, repair or rehabilitation upon said premises; (5) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (6) make no material alterations in said premises except as required by law or municipal ordinance without the prior consent of Mortgagee. PROVIDED, HOWEVER, such repair, restoration or rebuilding must begin within thirty (30) days of the date of this Nortgage.
- Payment of Taxes, Charges, etc. Mortga fors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges, including but not limited to leases and ground rents, against the premises when due, and shall, upon written request, furnish to the Mortgagee duplicate receipts thereof. To prevent default hereunder, Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- Reimbursement for Taxes Imposed on the Mortgagee. In the event of the enactment after this date of any law of Illinois deducting from the value of land for the purpose of taxition any lien thereon, or imposing upon the Mortgagee the payment of the whole or any part of the taxes or assessments or charges or liens herein required to be paid by Mortgagers, or changing in any way the law relating to the taxition of mortgages or debts secured by Mortgagee or the Mortgagee's interest in the property, or the manner of collection of taxes, so and to affect this Mortgage or the debt secured hereby or the holder thereof, then pay such taxes coassessments, or reimburse the Mortgagee therefor; provided, however, that if in the opinion of counsel for the Mortgagee (a) it might be unlawful to require Mortgagors to make such payment or (b) the making of such payment might result in the imposition of interest beyond the maximum amount permitted by law, then and in such event, the Mortgagee may elact, by notice in writing given to the Mortgagors, to declare all of the indebtedness secured hereby to be and become due and payable sixty (60) days from the giving of such notice.
- 7. Tax Due Because of Issuance of this Mortgage. If, by the laws of the United States of America or of any state having jurisdiction in the premises, any tax is due or becomes due in respect of the issuance of the Mortgage Note hereby secured, the Mortgagors covenant and agree to pay such tax in the manner required by any such law. The Mortgagors further covenant to hold harmless and agree to indemnify the Mortgagee, and the Mortgagee's successors or assigns, against any liability incurred by reasons of imposition of any tax on the issuance of the Mortgage Note secured hereby.
- B. Insurance. Mortgagors shall keep the improvements now existing or hereafter erected on the premises insured under a replacement cost form of insurance policy against loss or damage resulting from fire, windstorm and other hazards as may be required by Mortgagee, and to pay promptly, when due, any premiums on such insurance. Said insurance shall name the Mortgagee as an additional insured and shall be kept in effect during the course of the rehabilitation project and for the term of this Mortgage. The Mortgagors shall provide the Mortgagee with evidence that said insurance is in effect upon written request of the Mortgagee.
- 9. Acknowledgment of Debt. Mortgagors shall furnish from time to time within fifteen (15) days after

Mortgagee's written request, a written statement, duly acknowledged, of the amount due upon this Mortgage and whether any alleged offsets or defenses exist against the indebtedness secured by this Mortgage.

- 10. Mortgagee's Options in Case of Default. In case of default therein, Mortgagee may, but need not, make any payment or perform any act herein before required of Mortgagors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting said premises or contest any tax or assessment, and, if any action is commenced, upon notice to Mortgagors, may make appearances, disburse such sums, including by not limited to reasonable attorney's fees, and take such action as is necessary to protect Mortgagee's interest. All moneys paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, including attorneys' fees, and any other moneys advanced by Mortgagee to protect the inortgaged premises and the lien hereof, shall be so much additional indebtedness secured hereby and shall become immediately due and payable without notice and with interest thereon at the highest rate now permitted by Illinois law. Inaction of Mortgagee shall never be considered as a waiver of any right accruing to the Mortgagee on account of any default hereunder on the part of the Mortgagors.
- 11. Payment of Taxes by Mortgagors. The Mortgagors making any payment hereby authorized relating to taxes or assessments, may are so according to any bill, statement or estimate procured from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lier or title or claim thereof.
- 12. Time to Cure Default. The mortograps shall pay each item of the Mortgage herein mentioned, including but not limited to the indebtedness evidenced by the Junior Note, both principal and interest, when due according to the terms hereof and of the Junior Note. At the option of the Mortgagee and without notice to the Mortgagors all unpaid indebtedness secured by this Mortgage shall, notwithstanding anything in the Junior Note or in this Mortgage to the contrary, become due and payable all upon the failure of Mortgagors to punctually pay when due any installment of principal or interest due under the inortgage Note and remains uncured after ten (10) days written notice or (b) when default shall occur and continue for thirty (30) days in the performance of any other agreement of the Mortgagors herein contained or contained in the Mortgage Note or the Single-Family Rehabilitation Program Owners Participation Agreement.
- 13. Events of Default. The following events, in addition to any others specified herein, shall constitute a default in the terms of this Mortgage:
- (A) Discovery by the Mortgagee of any material misrepresentation; fraud or falsity in any representation, statement, affidavit, certificates, exhibit or instrument given or delivered by Nortgagers to the Mortgagee in connection with the making of this Mortgage, Mortgage Note or the Single-Family dehabilitation Program Owners Participation Agreement; or,
- (B) The voluntary or involuntary bankruptcy of Mortgagors, exchange, dispositio i, refinancing, or sale under foreclosure of the property; or,
- (C) The acquisition in whole or in part, voluntary or involuntary, of title, the beneficial interest, or the equity of redemption in the property by any party other than Mortgagors except where such transfer is approved in writing by the Mortgagee and the remaining principal and interest due on the Mortgage Note and this Mortgage is paid in full.
- (D) The balance of the mortgage loan payable to The Village of Streamwood, becoming declared due and payable with applicable municipal codes and "Section 8 Housing Quality Standards," or,
- (E) The failure of Mortgagors to maintain the subject property in compliance with applicable municipal codes and "Section 8 Housing Quality Standards"; or,
- (F) Any change in the form of ownership of the subject property or any portion thereof or any change in partners in the partnership without prior written consent of Mortgagee; or
- (G) Failure to comply with any other provisions of this Mortgage, the Mortgage Note and the Single-Family Rehabilitation Program Owners Participation Agreement.

- Methods of Enforcement; Costs. A) When the indebtedness hereby secured shall be due, whether by acceleration or otherwise, Mortgagee shall have the right to foreclose the lien hereof. In any suit to foreclose the lien hereof or in other actions in relation to the property as set out in subparagraphs (a, (b or (c of this paragraph, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures and expenses which may be paid or incurred by or on behalf of Mortgagee of attorney's fees, appraiser's fees, outlays for 'documentary and expert evidence, stenographers' charges, publication costs (which may be estimated as to items to be expended after entry of the decree), of procuring all such abstracts of title, title searches and examinations, title insurance policies. Torrens certificates, and similar data and assurances with respect to title as Mortgagee may deem to be reasonably necessary either to prosecute such suit or to evidence to bidders at any sale which may be had pursuant to such decree the true condition of the title to or the value of the premises. All expenditures and expenses of the nature in this paragraph mentioned shall become so much additional indebtedness secured hereby and immediately due and payable, with interest thereon at the highest rate then permitted by illinois law (or in the absence of such limit at 12%), when paid or incurred by Mortgagee in connection with (a any proceeding, including probate proceedings and actions in relation to the enforcement of foreclosure actions, perfection of assignments of Route the voluntary or involuntary bankruptcy of the Mortgagor and litigation arising therefrom, assignments for the benefit of creditors and adjudication of affirmative defenses, counterclaims, set-offs or recoupments against the claim of the Mortgagee, to which the Mortgagee shall be a party, either as plaintiff, claiment or defendant, by reason of this Mortgage or any indebtedness hereby secured; or (b) preparations for the commencement of any suit to foreclosure hereof after accrual of such right to foreclose whether or not actually commenced; or (c. preparations for the defense of any actual or threatened suit or proceeding which might affect the premises or the security hered. B) Notwithstanding Mortgagee's acceleration of the sums secured by this Mortgage due to Mortgagors due to Mortgagors' breach, Mortgagors shall have the right to have any proceedings begun by Mortgagors to enforce this increage discontinued at any time prior to entry of a judgment enforcing this Mortgage if: a) Mortgagors pay Mortgage e all sums which would be then due under this Mortgage and Mortgage Note had no acceleration occurred; b). Mortgagors cure all breaches of any other covenants or agreements of Mortgagors contained in this Mortgage; Ic Mortgagors pay all reasonable expenses incurred by Mortgagoe In enforcing the covenants and agreements of Mortgegors contained in this Mortgage, and in enforcing Mortgagee's remedies as provided in paragraph 14(A) hereof; including, but not limited to, reasonable attorney's fees; and d) that lien of this Mortgage, Mortgagee's interest in the property and Mortgagors' obligation to pay the sums secured by this Mortgagors' obligation to pay the sums secured by this Mortgage shall continue unimpaired. Upon such payment cure by Mortgagors, this Mortgage and the objections secured hereby shall remain in full force and effect as if no acceleration had occurred.
- 15. Priority of Distribution of Proceeds on Foreclosure. The proceeds of any foreclosure sale of the premises shall be distributed and applied in the following order of priority. First, on account of all costs and expenses incident to the foreclosure proceedings; including all such items as are mentioned in the paragraph 14 hereof; second, all other items which under the terms hereof constitute secured indeptacress additional to that evidenced by the Junior Note, with interest thereon as herein provided; third all principal and interest remaining unpaid on the Junior Note; fourth, any overplus to Mortgagors, their heirs, legal representatives or assigns, as their rights may appear.
- Appointment of Receiver on Foreclosure; Rents; Costs due to Receiver. Upon or at gay time the filing of a 16. complaint to foreclose this Mortgage, the court in which such compliant is filed may appoint a receiver of said premises. Such appointment may be made either before or after sale, without notice, without regard to the solvency or insolvency of Mortgagors at the time of application for such receiver and without regard to the then value of the premises or whether the same shall be then occupied as a homestead or not, and the Mortgagee may be appointed as such receiver. Such receiver shall give power to collect the rents, issues and profits of said premises, if any, during the pendency of such foreclosure suit, and in case of sale and a deficiency, during the full statutory period of redemption, whether there be redemption or not, as well as during any further times when Mortgagors, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits and all other powers which may be necessary or are usual in such cases for the protection, possession, control management and operation of premises during the whole of said period. The Court from time to time may authorize the receiver to apply the net income in his hands in payment in whole or in part of: 1) the indebetedness secured hereby, or by any decree foreclosing this Mortgage, or any tax, special assessment or other lien which may be or become superior to the lien hereof or of such decree, provided such application is made pricer to foreclosure sale; 2) the deficiency in the case of a sale and deficiency.
- 17. Appointment of Receiver on Acceleration; Collection of Rents. Upon acceleration under this Mortgage

hereof or abandonment of the property, Mortgagors shall be entitled to have a receiver appointed by a court to enter upon, take possession of and manage the property and to collect the rents of the property, if any, including those past due. All rents, if any, collected by the receiver shall be applied first to payment of the costs of management of the property and collection of rents, including, but not limited to, receiver's fees, premiums on receiver's bonds and reasonable attorney's fees, and then to the sums secured by this Mortgage. The receiver shall be liable to account only for those rents actually received.

- Defenses. No action for the enforcement of the lien or of any provision hereof shall be subject to any 18. defense which would not be good and available to the party interposing same in action at law upon the Mortgage Note hereby secured.
- Inspection of Premises. The Mortgagee shall have the right to inspect or may cause the inspection of the 19. premises at all reasonable times and access thereto shall be permitted for that purpose.
- Extension, Variation or Release of the Debt. If the payment of said indebtedness or any part thereof be 20. extended or varied or f any part of the security be released, all persons not or at any time hereafter liable therefor, or interested in said premises, shall be held to assent to such extension, variation or release, and their liability and the lien and all provisions hereof shall continue in full force, the right of recourse against all such persons being expressly reserved by the Mortgagee, notwithstanding such extension, variation or release.
- Release of Lien. Mortgager shall release the Mortgage and lien thereof by proper instrument upon payment 21. and discharge of all indebtedness secured hereby and payment of a reasonable fee to Mortgagee for the execution of such release.
- Definition of Mortgagors and Mortgage). This Mortgage and all provisions hereof, shall extend to and be 22. binding upon Mortgagors and all persons claiming under or through Mortgagors and the word "Mortgagors" when used herein shall include all such persons and all persons liable for the payment of the indebtedness of any part thereof, whether or not such persons shall have big uted the Mortgage Note of this Mortgage. The Word "Mortgagee" when used herein shall include the successors and assigns of the Mortgagee named herein and the holder or holders, from time to time, of the Junior Note secured hereby.
- Applicable Laws; Severability. The state and local laws applicable to this Mortgage shall be the laws of the 23. jurisdiction in which the property is located. The foregoing sentence shall not limit the applicability of Federal law to this Mortgage. In the event that any provision or clause of this Mortgage, the Mortgage Note or the Single-Family Rehabilitation Program Owners Participation Agreement conflicts with applicable law, such conflict shall not affect other provisions of this Mortgage or of the Mortgage Note which can be given effect without the conflicting provisions, and to this end the provisions of this Mortgage, the Mortgage No. and the Single-Family Rehabilitation Program Gwners Participation Agreement are declared to be severable.
- Notice Due on Breach. Upon Mortgagors' breach of any covenant or agreement of Mortgagors in this 24. Mortgage, including the covenants to pay when due any sums secured by this Mortgage, Mortgagee prior to the acceleration shall give notice to Mortgagors specifying: 1) the breach; 2) the action required to cure such breach; acceleration.

  which such breach must be cured; and 4) that failure to cure such notice may result in acceleration of the sums secured by this Mortgage, foreclosure of property.
