TOGETHER WITH all the improvements now or hereafter erected on the property, and all easements, appurtenances, and fixtures now or hereafter a part of the property. All replacements and additions shall also be covered by this Security Instrument. All of the foregoing is referred to in this Security Instrument as the "Property."

BORROWER COVENANTS that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property and that the Property is unencumbered, except for encumbrances of record. Borrower warrant, and will defend generally the title to the Property against all claims and demands, subject to any encumbrances of record.

- 2. Funds for Taxes and Insurance. Lender may, at any time, collect and hold Fonds in an amount not to exceed the maximum amount a Lender for a federally related mortgage loan may tender for Borrower's escrow account under the federal Real Estate Settlement Procedures Act of 1974 as amended from time to time, 12 U.S.C. § 2601 et seq. If the Funds held by Lender exceed the amounts permitted to be held by applicable law, Lender shall account to Borrower for the excess Funds in accordance with the requirements of applicable law. If the amount of the Funds held by Lender at any time is not sufficient to pay the Escrow Items when due, Lender may so notify Borrower in writing, and, in such case Borrower shall pay to Lender the amount necessary to make up the deficiency. - 4. Charges; Liens. 5. Hazard or Property Insurance. Borrower shall not destroy, damage or impair the Property, allow the Property to deteriorate, or commit waste on the Property.
