THIS ADJUSTABLE RATE RIDER is made this 18TH day of NOVEMBER, 1996, and is increor ated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Security Deed (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure Borrower's Adjustable Rate Note (the "Note") to SOUTHERN PACIFIC FUNDING CORPORATION, A CALIFORNIA CORPORATION

(the 'Lender') of the same date and covering the property described in the Security Instrument and located at:

THE NOTE CONTAINS PROVISIONS ALLOWING FOR CHANGES IN THE INTEREST RATE AND THE MONTHLY LAYMENT. THE NOTE LIMITS THE AMOUNT THE BORROWER'S INTEREST KAIE CAN CHANGE AT ANY ONE TIME AND THE MAXIMUM RATE THE BORROY/ER MUST PAY.

ADDITIONAL COVENANTS. In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

A. INTEREST RATE AND MONTHLY PAYMENT CHANGES

Subject to the limits stated in Section 4(D) below, this rounded amount will be my new interest rate until the next Change Date.
