Unit Number 23-CS, as delineated on survey of the following described parcel of real estate (hereinafter referred to as parcel) being for the same at the point where the West line of Lake Shore Drive (200 feet wide) intersects with the South Line of Scott Street (66 feet wide) and running thence along the West line of Lake Shore Drive 192 feet 2 1/8th inches, thence North at an angle of 88 degrees 17 minutes West 122 feet 9.5 inches to the East line of Stone Street (66 feet wide) thence along the East line of Stone Street North 192 feet 1-3/4th inches, to the South line of Scott Street aforesaid, and thence along the South line of Scott Street East 117 Feet 1-3/4th inches to the point of beginning being all of Lots 1 and 2 in Lawrence and Symonds Subdivision of Lots 1 and 2 and the North 15 feet of Lot 3 in Block 8 in H. O. Stone's subdivision of Astor's addition to Chicago the South 25 feet of Lot 3 all of Lot 4 and the North 32 feet of Lot 5, all in Block 8 in H. O. Stone's subdivision of Astor's addition to Chicago aforesaid, and all land derived by way of accretions or otherwise lying East of the East lines of said lots as originally subdivided West of the West line of Lake Shore Drive as now stablished in Cook County, Illinois, all situated in the City of Chicago which survey is attached as Exhibit 'A' to the declaration made by La Salle National Bank as trustee under trust number 36853 recorded in the Office of the Recorder of Cook County, Illinois as document 20892901 and amended by document number 20946638 recorded September 2, 1969 together with an undivided percentage comprising all the units thereof as defined and set forth in said declaration and survey) in Cook County, Illinois.
