This instrument is given to secure payment of the principal sum of One Hundred Thirty Four Thousand and 00/100 (\$134,000.00) Dollars and interest upon two certain Installment Notes, the first being in the principal sum of Sixty Thousand and 00/100 (\$60,000.00) Dollars and the second being in the principal sum of Seventy Four Thousand and 00/100 (\$74,000.00) Dollars, said Notes being secured by Mortgage or Trust Deed to INDEPENDENT TRUST CORPORATION, as Trustee, dated November 8, 1996 and recorded in the Recorder's Office of the above named county, conveying the real estate and premises hereinabove described. Without limitation of any of the legal rights of Assignee as the absolute assignee of the rents, issues and profits of said real estate and premises above described, and by way of enumeration only, it is agreed that in the event of any default under the said Trust Deed or Mortgage above described, whether before or after the Notes secured by said Trust Deed or Mortgage is or are declared to be due in accordance with the terms of said Trust Deed or Mortgage, or whether before or after the institution of any legal proceedings to foreclose the lien of said Trust Deed or Mortgage, or before or after thy sale thereunder, Assignee shall be entitled to take actual possession of said real estate and premises hereinabove described, or any of any part thereof, personally or by agent or attorney, as for condition broken and may with or without force, and with or without process of law, and without any action on the part of the holder or holders of the premises hereinabove described, together with all documents, books, records, papers and accounts relating thereto, and may exclude Assignor, is beneficiaries or their agents or servants, wholly therefrom, and may hold operate, manage and control the said real estate and premises hereinabove described and conduct the business thereof. Assignee may, at the expense of the mortgaged property, from time to time, cause to be made all necessary or proper repairs, renewals, replacements, useful alterations, additions, betterments and improvements to the said real estate and premises as may seem judicious, and may insure and reinsure the same, and may lease said mortgaged property in such parcels and for such times and on such terms as may seem fit, including leases for terms expiring beyond the maturity of the indebtedness secured by said Trust Deed or Mortgage and may cancel any lease or sublease for any cause or on any ground which would entitle Assignor or its beneficiaries to cancel same.
