Pages 2 through 4 hereby amend PAGE 1 of EXHIBIT "A" to show Additional Property.
- EXHIBIT "B" at ached to the Declaration aforesaid is hereby amended and superseded in its entirety by EXHIGIT 'B" attached hereto, and the respective percentages of ownership in the Common Elements appurtenant to each Unit described in said EXHIBIT "B" to the Declaration prior to this Amendment are hereby reduced to the respective percentages set forth in EXHIBIT "B" hereto. Any reference in the Declaration to EXHIBIT "B" shall be deemed to refer to EXHIBIT "B" as amended hereby.
- 5. All the Unit owners and mortgage holders, by ALSIP INDUSTRIAL

  PARTNERS, an Illinois Partnership hereby consent to this Amendment to the Declaration

  pursuant to the power set forth in ARTICLE XII of the Declaration.
- 6. Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms

THIS DECLARATION is executed by the HERITAGE TRUST COMPANY, as Trustee as aforesaid, and not personally, in the exercise of the power and authority conferred upon and vested in it as such Trustee, (and the HERITAGE TRUST COMPANY hereby warrants that it possesses full power and authority to execute this instrument). It is expressly understood and agreed by every person, firm or corporation hereafter claiming any interest under this Declaration that the HERITAGE TRUST COMPANY, as Trustee aforesaid, and not personally, has joined in the execution of this Declaration for the sole purpose of subjecting the title-holding interest and the trust estate under said Trust No. 9391 to the terms of this Declaration; that any and all obligations, duties, covenants and agreements of every nature herein set forth by the HERITAGE TRUST COMPANY, a Trustee as aforesaid, to be kept or performed, are intended to be kept, performed and discharged by the beneficiaries under said Trust No. 88-3507 or their successors, and not by the HERITAGE TRUST COMPANY either personally or as such Trustee, to sequester trust assets, rentals, avails, or proceeds of any kind or otherwise to see to the fulfillment or discharge of any obligations, express or implied, arising under the terms of this Agreement, except where said Trustee is acting pursuant to direction as provided by the terms of said Trust No. 88-3507 and after the Trustee has first been supplied with funds required for the purpose. In the event of conflict between the terms of this Paragraph and of the remainder of the Declaration on any question or apparent liability or obligation resting upon said Trustee, the exculpatory provisions hereof shall be controlling.
