Grantor. The word "Grantor" means DEAN A BURNS and SUSAN M BURNS. The Grantor is the mortg igor under this Mortgage.

Guarantor. The word "Guarantor" means and includes without limitation, each and all of the guarant ire. suratios, and accommodation parties in connection with the indebtedness.

The word "Indebtedness" mouns all principal and interest payable under the Note and any amounts expended or advanced by Lender to discharge obligations of Grantor or expenses incurred by Lander to enforce obligations of Grantor under this Mortgage, together with interest on such amounts as provided in this Mortgage.

Mortgage. Payment. Grantor shall pay when due (and in all events prior to delinquency) all taxes, payroll taxes, special taxes, assessments, water charges and sower service charges levied against or on account of the Property, and shall pay when due all claims for work done on or for services randered or material furnished to the Property. PROPERTY DAMAGE INSURANCE. The following provisions relating to insuring the Property are a part of this Mortgage.
