Credit Agreement. The maturity date of the obligations secured by this Mortgage is November 29, 2011. The interest rate under the Credit Agreement is a variable interest rate based upon an index. The index currently is 8,250% per annum. The interest rate to be applied to the outstanding account balance shall be at a rate 2,000 percentage points above the index, subject however to the following maximum rate. Under no circumstances shall the interest rate be more than the lesser of 19,800% per annum or the maximum rate allowed by applicable law.

Existing Indobtedness. The words "Existing Indebtedness" mean the indebtedness described below in the Existing Indebtedness section of this Mortgage.

Grantor. The word "Grantor" means EDDY L CHAMP and ZELIA CHAMP. The Grantor is the mortgager under this Mortgage.

POSSESSION AND MAINTENANCE OF THE PROPERTY. Grantor agrees that Grantor's possession and use of the Property shall be governed by the following provisions:

Possession and Use. Until in default, Grantor may remain in possession and control of and operate and manage the Real Property and collect the Rents.
