Article 5. Other Provisions.

The corporation shall have one class of membership, consisting (a) of the respective owners of Units in the Condominium. Each Unit Owner shall be a member of the Association so long as he shall be a Unit Owner. A Unit Owner's membership in the Association shall automatically terminate when he ceases to be a Unit Owner. Upon the conveyance or transfer of a Unit Owner's ownership interest in his Unit to a new Unit Owner, the new Unit Owner shall simultaneously with such conveyance succeed to the former Unit Owner's membership in the Association. The aggregate number of votes for all Unit Owners shall be equal to one hundred which, except for certain exceptions as are specified in the Bylaws, shall be divided among the respective Unit Owners in accordance with their respective percentages of ownership interests in the Common Elements. If any Unit Owner consists of more than one person, the voting rights of such Unit Owner shall not be divided, but shall be exercised as if the Unit Owner consisted of only one person in accordance with the proxy or other designation inside by agreement of the persons constituting such Unit Owner.

(b) The regulation of the internal affairs of the corporation, including the distribution of assets on dissolution, to the extent not inconsistent with law, shall be governed by the terms and provisions of the Declaration, including, but not limited to, the Bylaws attached thereto as Exhibit C and made a part thereof, as either or both of the same e m. Colling Control may, from time to time, be amended in the manner therein specified.
