Ordinance by the Council of the Village of Winnetka, recorded March 7, 1922, as Document Number 7420508 to classify, regulate and limit the height and bulk of buildings hereafter erected to regulate and limit the intensity of the use of lot areas and to regulate and determine the area of courts and open spaces within and surrounding such buildings and to establish the boundaries of districts for said purposes and prescribing penalties for the violation of its provisions.

An easement in perpetuity as private ways for use (in severalty) as a mean of ingress and egress and for public utilities for the benefit of lots in above subdivision and for use as a means of ingress and egress in common with lots in any Subdivision of the East Half (1) of the South West Quarter (1) and the South West Quarter (1) of the South East Quarter (1) of Section 20 aforesaid.

Said restrictions are covenants running with the land for the benefit of the owners of lots in said Subdivision, etc., contained in Deed Doc. No. 472184.
