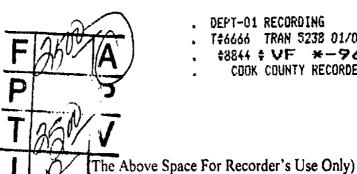

#### TRUST POWERS
