ORDINANCE NO. 95-036

AN ORDINANCE REZONING PROPERTY LOCATED ON THE NORTH SIDE OF THORNTON LANSING, ROAD WEST OF STONEY ISLAND AVENUE, LANSING, ILLINOIS, FROM R-1 SINGLE FAMILY RESIDENTIAL TO M-1, LIMITED MANUFACTURING DISTRICT

WHEREAS, a perition for rezoning has been filed before the Planning and Zoning Board of Appeals for the VILLAGE OF LANSING, Cook County, Illinois; and

WHEREAS, on the 1st day of March, 1995, a public hearing was conducted as required by law, due notice having been published, and all further legal requirements met to conduct said public hearing; and

WHEREAS, the Master Plan for the VILLAGE OF LANSING indicates that this general area should be developed and used for commercial purposes.

NOW, THEREFORE, BE IT ORDAINED BY THE MA (OR/PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LANSING, in the exercise of its home rule powers as follows:

Section 1: That the property legally described in Exhibit "A", which is attached hereto and expressly incorporated herein, be and the same hereby rezoned from R-1 Single Family Loudential to M-1 Limited Manufacturing District, to allow for the construction and operation of a Tree Pernoval Service, including a building to store and repair equipment and the storage of cut trees, in substantial or impliance with the character of the neighborhood and conditioned upon the requirement that the Petitioner comply with all safety recommendations of the Lansing Fire Department.

Section 2: That the Village Clerk is hereby directed to change the official zoning map of the VILLAGE OF LANSING, and all pertinent records, to show the change of zoning of the described property in accordance with the provisions of this Ordinance as provided by law.

Section 3: That all ordinances or parts of ordinances in conflict with the provision of this Ordinance be, and the same is hereby repealed.


