THIS AGREEMENT
("Agreement") is made as of the

WHEREAS, Evan is the owner of the land located in Cook County, Illinois, legally described on Exhibit A attached hereto and hereby made a part hereof ("Ryan Land"), and Bertucci's is the owner of the adjoining land located in Cook County, Illinois, legally described on Exhibit B attached hereto and hereby made a part hereof ("Bertucci's Land");

WHEREAS, Bertucci's has requested that Ryan, as an Approving Party under that certain Operation and Easement Agreement dated April 14, 1993, and recorded with the Cook County Recorder as Document No. 93351020, as amended ("OEA"), approve plans ("Plans") for construction of a restaurant building ("Building") on the Bertucci's Land in the location desired by Bertucci's; and

WHEREAS, Ryan has agreed to approve the Fians, subject to the agreements by Bertucci's set forth herein.
