#### SECOND MODIFICATION AGREEMENT

This SECOND MODIFICATION AGREEMENT dated as of November 30, 1995, by and among ORCHARD PARK LIMITED PARTNERSHIP, an Illinois limited partnership (the "Mortgagor"), ORCHARD PARK, L.L.C., an Illinois limited liability company (the "General Partner"), CHICAGO METROPOLITAN HOUSING DEVELOPMENT CORPORATION, an Illinois not for profit corporation (the "Guarantor"), and LASALLE NATIONAL BANK, a national banking association (the "Bank");

#### WITNESSETH:

WHEREAS, the Mortgagor the General Partner, the Guarantor and the Bank heretofore obtained into the following documents (collectively, the "Documents"):

- (1) Construction Loan Agreement dated as of February 1, 1995, by and between the Mortgagor and the Bank;
- (ii) Construction Loan Mortgage Note dated February 1, 1995 (the "Note"), from the Mortgagor to the Bank in the principal amount of \$1,700,000;
- (iii) Construction Loan Mortgage and Security Agreement dated as of February 1, 1995, from the Mortgagor to the



WHEREAS, the Documents were previously modified and amended by the Modification Agreement dated as of September 30, 1995 (the "First Modification"), by and among the Mortgagor, the General Partner, the Guarantor and the Bank, recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on the date of the recording of this Agreement, and

WHEREAS, the Documents, as modified and amended by the First Modification, encumber the real estate described in <u>Axhibit</u> attached hereto and the personal property located thereon; and

WHEREAS, the parties desire to make certain modifications and amendments to the Documents, as previously modified and amended by the First Modification, as more fully provided for herein;

NOW, THEREFORE, in consideration of the premises and the mutual covenants and agreements contained herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

Section 1. Recitals Part of Agreement: References to Documents. The foregoing recitals are hereby incorporated into

and made a part of this Agreement. Except as otherwise stated herein, all references in this Agreement to any one or more of the Documents shall be deemed to include the previous modifications and amendments to the Documents provided for in the First Modification, whether or not express reference is made to such previous modifications and amendments.

Section 2. Extension of Maturity Date. The maturity date of the loan which is evidenced and secured by the Documents, as previously extended by the First Modification, is hereby further extended from November 30, 1995, to January 31, 1996, and all of the Documents are hereby modified and amended accordingly. Without limitation on the generality of the foregoing, the date "November 30, 1995" is hereby changed to "January 31, 1996" each time it appears in the Documents, as modified and amended by the First Modification.

Section 1. Attachment to Note. The Bank may, and prior to any transfer by it of the Note shall, attach a copy of this Agreement to the original Note and place an endorsement on the original Note making reference to the fact that such attachment has been mide.

Section 4. Documents to Remain in Effect: Confirmation of Obligations: References. The Documents shall remain in full force and effect as originally executed and delivered by the parties, except as previously modified and amended by the First Modification and as expressly modified and amended herein. The Mortgagor, the General Partner and the Guarantor hereby (1) confirm and reaffirm all of their obligations under the Documents, as previously modified and imended by the First Modification and as modified and amended nevern; (ii) acknowledge and agree that the Bank, by entering into this Agreement, does not waive any existing or future default or event of default under any of the Documents, or any rights or remedies under any of the Documents, except as expressly provided herein; (iii) acknowledge and agree that the Bank has not heretofore waived any default or event of default under any of the Documents, or any rights or remedies under any of the Documents; and (iv) acknowledge that they do not have any defense, set-off or counterclaim to the payment or performance of any of their obligations under the Documents, as previously modified and amended by the First Modification and as modified and amended herein. All references in the Documents to any one or more of the Documents, or to the "Loan Documents," shall be deemed to refer to such Document, Documents or Loan Documents, as the case may be, as previously modified and amended by the First Modification and as modified and amended by this Agreement.

- Section 5. Certifications, Representations and Warranties. In order to induce the Bank to enter into this Agreement, the Mortgagor, the General Partner and the Guarantor hereby certify, represent and warrant to the Bank that all certifications, representations and warranties contained in the Documents and in all certificates heretofore delivered to the Bank are true and correct as of the date hereof, and all such certifications, representations and warranties are hereby remade and made to speak as of the date of this Agreement.
- Section 6. Entire Agreement. This Agreement sets forth 411 of the covenants, promises, agreements, conditions and understandings of the parties relating to the subject matter of this Agraement, and there are no covenants, promises, agreements, conditions or understandings, either oral or written, between them other than as are herein set forth.
- Section 7. Successors. This Agreement shall inure to the benefit of and shall be binding upon the parties and their respective successors, assigns and legal representatives.
- Section 8. Severability. In the event any provision of this Agreement shall be held invalid or unenforceable by any court of competent jurisdiction, such holding shall not invalidate or render unenforceable any other provision hereof.
- Section 9. Amendment. Changes and Modifications. This Agreement may be amended, changed, modified, altered or terminated only by a written instrument executed by all of the parties hereto.

#### Section 10. Construction.

- (a) The words "hereof," "herein," and "hereunder," and other words of a similar import refer to this igreement as a whole and not to the individual Sections in which such terms are used.
- (b) References to Sections and other subdivisions of this Agreement are to the designated Sections and other subdivisions of this Agreement as originally executed.
- (c) The headings of this Agreement are for convenience only and shall not define or limit the provisions hereof.
- (d) Where the context so requires, words used in singular shall include the plural and vice versa, and words of one gender shall include all other genders.

(e) The Mortgagor, the General Partner, the Guarantor and the Bank, and their respective legal counsel, have participated in the drafting of this Agreement, and accordingly the general rule of construction to the effect that any ambiguities in a contract are to be resolved against the party drafting the contract shall not be employed in the construction and interpretation of this Agreement.

Section 11. Execution of Counterparts. This Agreement may be simultaneously executed in several counterparts, each of which shall be an original and all of which shall constitute but one and the same instrument.

Section 12. Governing Law. This Agreement is prepared and entered into with the intention that the law of the State of
