THIS SUBORDANATION AGREEMENT, made in the City of Chicago, State of Illinois this 4th day of January, 1996 by The First National Bark of Chicago, a national banking association organized and existing under and by virtue of the laws of the United States of America, and doing business and having its principal office in the City of Chicago, County of Cook, and State of Illinois ("Bank").

WITNESSETH

WHEREAS, the Bank is the owner of a mortgage dated. September 21, 1994 and recorded. September 29, 1994 among the land records in the Office of the Recorder of Deeds of Cook County, Illinois as Document Number. 94844068 made by Timothy R. High and Norma S. Barron-High, Husband and Wife ("Borrowers"), to secure an indebtedness of \$28,000.00 ("Mortgage"); and

WHERE 18. The William Block Company, Its Successors and/or Its Assigns, its successors (c/or assigns ("Mortgagee") has refused to make a loan to the Borrowers of \$ 100,000.00, except upon condition that the Mortgage be subordinate to said mortgage lien of Mortgagee.

NOW, THEREFORE, in consideration of the sum of Ten (\$10.00) Dollars in hand paid by each of the puries hereto to the other, and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and in order to induce Mortgagee to make the loan to Borrowers, it is hereby mutually agreed, as follows:

- I. That the Bank covenants and consents that the lien of its Mortgage shall be subject and subordinate to the lien of Mortgagee's mortgage dated _______ reflecting and securing the loan made by Mortgagee to Borrowers, in the amount of One Hundred Thousand and no/100 Dollars, and to all renewals, extensions or replacements of said mortgage; and
- II. That this Agreement shall be binding upon and shall inure to the benefit of Mortgagee, its successors and assigns.
