This Amendment to the Declaration of Condominium Ownership and of Easements. Restrictions and Covenants and By-Laws of the Park Lynn Condominium, made and entered into this 15 day of 1995, by the Board of Managers of Park Lynn Condominium (hereinafter referred to as the "Poord") and the undersigned Unit Owners of condominium units in Park Lynn Condominium (hereinafter referred to as the "Unit Owners"), having at least three-fourths (3/4) of the total vote of the membership of Park Lynn Condominium.

#### WITNESSETH:

WHEREAS, by a certain Declaration of Condominium Ownership of Park Lynn Condominium filed in the Office of the Recorder of Deeds of Cook County, Illinois as Document Number 24113712 (hereinafter referred to as the "Declaration"), certain real estate was submitted to the Condominium Property Act of the State of Illinois, said condominium being known as Park Lynn Condominium. The real estate subject to the Declaration as a result of the recordation of the Declaration is identified and legally described on Enhibit A attached hereto and forming a part hereof.

WHEREAS, Article X, Section A of the Declaration sets forth the procedure for amendment, change or modification of the Declaration by written instrument setting forth the change, modification or rescission, signed and acknowledged by the Association and the Owners having at least three-fourths (3/4) of the total vote; provided, however, that all lien

holders of record have been notified by certified mail of such change, modification or rescission, and an affidavit by an officer of the Association certifying to such mailing is a part of such instrument;

WHEREAS, Article V of the By-Laws attached as Exhibit C to the Declaration sets forth the procedure for amendment or modification of the By-Laws by written instrument setting forth the amendment or modification, signed and acknowledged by the Owners having at least seventy-five percent (75%) of the total vote;

WHEREAS, the Board and Unit Owners desire to prohibit the keeping, breeding or maintaining of animals, including dogs, cats and other four-legged animals in the units;

NOW THEREFORE, the Board and Unit Owners having at least three-fourths (3/4) or seventy-five percent (75%) of the total vote, do hereby amend the Declaration and By-Laws as follows:

Section 3 of Article IV of the By-Laws attached as Exhibit C to the Declaration is hereby deleted in its entirety and the following language is substituted in its place and stead.

Section 3. No animals, reptiles, rabbits, livestock, fowl or poultry of any kind shall be raised, bred or kept in any Unit or in the Common Elements. All dogs, cats and other four-legged animals are prohibited from being raised, bred or kept in any Unit or in the Common Elements, except that any Unit Owner who owns and keeps or maintains a dog, cat or other four-legged animal in the Unit as of the effective date of this Amendment may keep or maintain such existing dog, cat or four-legged animal for the lifetime of said pet. The Unit Owner shall be subject to all other rights, obligations, restrictions, rules and regulations adopted by the Association; and provided further the existing dog, cat or four-legged animal shall be subject to being removed, upon three (3) days' written notice from the Board to the Owner; if it causes or creates a nuisance, annoyance, unreasonable disturbance or otherwise is in violation of the rules and regulations, as determined in the sole discretion of the Board. All such issues and violations shall be covenant violations and may be remedied in accordance with the remedies provisions of this Declaration.
