- 4. ASSIGNMENT. In consideration of the Loan, Owner assigns, bargains, sells and conveys to Bank all of Owner's right, title and interest in and to all tents and profits from the Property and all leases of the Property now or hereafter made, effective immediately upon the execution of this Agreement (all of which are collectively known as the Collateral), which Collateral is described as follows:
 - A. all leases (Leases) on the Property. The term "Leases" in this Agreement shall include all agreements, written or verbal, existing or hereulter arising, for the use or occupancy of any portion of the Property and all extensions, renewals, and substitutions of such agreements, including subleases thereunder.

B. all guaranties of the performance of any party under the Leases.

- C. the right to coller; and receive all revenue (Rent) from the Leases on the Property now due or which may become due. Rent includes, but is not limited to the following: revenue, issue, profits, rent, minimum rent, percentage rent, additional rent, common area maintenance charges, parking cnr.5e3, real estate taxes, other applicable taxes, security deposits, insurance premium contributions, liquidated damages following using unique uncertainty, "loss of rents" insurance or other proceeds, and all rights and claims which Owner may have against any person uncert the terms of the Leases.
- 5. COLLECTION OF RENT. Owner shall give notice of Bank's rights to all Rent and notice of direct payment to Bank to those obligated to pay Rent. Prior to an Event of Default, Owner may continue to collect all Rent from the Leases on the Property now due or which may become due. Owner agrees to direct all tenants that in certain instance i they may be required to pay Rent due or to become due to Bank. Owner shall endorse and deliver to Bank any money orders, checks or drains which represent Rent from the above-described Property, apply the proceeds to the Obligations, and give notice of Bank's rights in any of said Rent and invited direct payment to Bank to those obligated to pay such Rent. Bank shall be the creditor of each Lessee in respect to assignments for the benefit of creditors, bankruptcy, reorganization, rearrangement, insolvency, dissolution or receivership proceedings by Lessee, and Owner shall immediately pay over to Bank all sums Owner may receive as creditor from such actions or proceedings. Also, Bank may collect or receive all payments pay over to Bank all such payments as Owner may receive from any Lessee. Bank shall have the option to apply any amounts received as such creditor to the Obligations. The collection or receipt of any payments by Bank shall not constitute Bank as being a mortgagee in possession.
- 6. APPLICATION OF COLLATERAL PROCEEDS. Any Rent or other payment's received or to be received by virtue of the Collateral; will be applied to any amounts Borrower owns Bank on the Obligations and shall be applied the to costs and expenses, then to accrued interest and the balance, if any, to principal except as otherwise required by law.
- 7. WARRANTIES. To induce Bank to make the Loan, Owner makes the following represertations and warranties:
 - A. Owner has good title to the Leases and Rent and good right to assign them, an the other preson has any right in them;

B. Owner has duly performed all of the terms of the Leases that Owner is obligated to purion;

- C. Owner has not previously assigned or encumbered the Leases or the Rent and vill not further assign or encumber the Leases or future
 Rent:
- D. No Rent for any period subsequent to the current month has been collected or received from Lessee, and no Rent has been compromised. The term "Lessee" in this Agreement shall include all persons or entitles obligated to Owner under the Leases;
- E. Upon request by Bank, Owner will deliver to Bank a true and complete copy of an accounting of Rent which is current as of the date requested;
- F. Owner has compiled and will continue to comply with any applicable landlord-tenant laws;

G. No Lessee is in default of any of the terms of the Leases;

- H. Owner has not and will not waive or otherwise compromise any obligation of Lessee under the Leases and vill enforce the performance of every obligation to be performed by Lessee under the Leases;
- Owner will not modify the Leases without Bank's prior written consent, will not consent to any Lesses's assignment of the Leases, or any subletting thereunder, without Bank's prior written consent and will not sell or remove any personal property located on the Property unless replaced in like kind for like or better value; and
- J. Owner will not subordinate any Leases to any mortgage, lien, or encumbrance affecting the Property without Bank's whiten consent.
- 8. OWNER'S AGREEMENTS. In consideration of the Loan, Owner agrees:

 - H. that if the Leases provide for abatement of Rent during repair due to fire or other casually, Bank shall be provided satisfactory insurance

- that the Leases shall remain in full force and effect regardless of any merger of the Lessen's and Lessee's interests.
- 9. EVENTS OF DEFAULT. Owner shall be in default upon the occurrence of any of the following events, circumstances or conditions (Events of Default):

A. Failure by any party obligated on the Obligations to make payment when due; or

B. A default or breach by Borrower, Owner or any co-signer, endorser, surety, or guarantor under any of the terms of this Agreement, the Note, any construction loan agreement or other loan agreement, any security agreement, mortgage, deed to secure debt, deed of trust, trust deed, or any other document or instrument evidencing, guarantying, securing or otherwise relating to the Obligations; or

C. The making or furnishing of any verbal or written representation, statement or warranty to Bank which is or becomes false or incorrect in any material respect by or on behalf of Owner, Borrower, or any one of them, or any co-signer, endorser, surely or guaranter of the

Obligations; or

D. Failure to obtain or maintain the insurance coverages required by Bank, or insurance as is customary and proper for the Collabral (as

herein defined); or

E. The death, dissolution or insolvency of, the appointment of a receiver by or on behalf of, the assignment for the benefit of creditors by or on behalf of, the voluntary or involuntary termination of existence by, or the commencement of any proceeding under any present or future federal or state insolvency, bankruptcy, reorganization, composition or debtor relief law by or against Owner, Borrower, or any one of them, or any co-signer, endorser, surety or guarantor of the Obligations; or

F. A good laith belief by Bank at any time that Bank is insecure with respect to Borrower, or any co-signer, endorser, surety or guarantor, that the prospect of any payment is impaired or that the Collateral (as herein defined) is impaired; or

- G. Fallure to pay or provide proof of payment of any tax, assessment, rent, insurance premium, escrow or escrow deficiency on or before its due date: or
- H. A material adverse change in Owner's business, including ownership, management, and financial conditions, which in Bank's opinion, impairs the Collate at ci repayment of the Obligations; or
- 1. A transfer of a substant up in of Owner's money or property.
- 10. REMEDIES ON DEFAULT. At the option of Bank, all or any part of the principal of, and accrued interest on, the Obligations shall become immediately due and payable without not or demand, upon the occurrence of an Event of Default or at any time thereafter. In addition, upon the occurrence of an Event of Default or at any ima thereafter by Mortgagor under the Mortgage, Bank, at Bank's option, shall have the right to exercise any or all of the following remedies:

A. To continue to collect directly and retain Roat in Bank's name without taking possession of the Property and to demand, collect, receive, and sue for the Rent, giving proper receips and releases, and, after deducting all reasonable expenses of collection, apply the balance as

legally permitted to the Note, first to accrued interest and then to principal.

B. To recover reasonable attorneys' fees to the extent not prohibited by law.

To declare the Obligations immediately due and payable, and, at Bank's option, exercise any of the remedies provided by law, the Note,

the Mortgage or this Agreement.

To enter upon, take possession of, manage and operate of or any part of the Property, make, modify, enforce or cancel any Leases, evict any Lessee, increase or reduce Rent, decorate, clean and make repairs, and do any act or incur any cost Bank shall deem proper to protect the Property as fully as Owner could do, and to apply any unds collected from the operation of the Property in such order as Barity may deem proper, including, but not limited to, payment of the following: operating expenses, management, brokerage, altomeys' and accountants' fees, the Obligations, and toward the maintenance (1 reserves for repair or replacement. Bank may take such action without regard to the adequacy of the security, with or without any action or proceeding, through any person or agent, mortgages under a mortgage, or receiver to be appointed by a court, and irrespective of Courte's possession.

The collection and application of the Rent or the entry upon and taking possession of the Property as set out in this section shall not cure or waive any default, or modify or waive any notice of default under the Note, Mortgage or this Agreement, or invalidate any act done pursuant to such notice. The enforcement of such remedy by Bank, once exercised, shall continue for so long as Brink shall elect, notwithstanding that such collection and application of Rent may have cured the original default. If Bank shall thereafter elect to discontinue the exercise of any such remedy, the same or any other remedy under the law, the Note, Mortgage or this Agreement may be asserted at any floor and from time to time following any subsequent default. The word "default" has the same meaning as contained within the Note or any other instrument evidencing the Obligations, and the Mortgage, or any other document securing, guarantying or otherwise relating to the Obligations.

In addition, upon the occurrence of any Event of Default, Bank shall be entitled to all of the remedies provided by law, the Note and any related loan documents. All rights and remedies are cumulative and not exclusive, and Bank is entitled to all remedies provided at law or equity, whether or not expressly set forth.

- "Hazardous Substance" means any toxic, radioactive or hazardous material, waste, poliutant or contaminant which has characteristics which render the substance dangerous or potentially dangerous to the public health, ealery, welfare or the environment. The term includes, without limitation, any substances defined as "hazardous material," "toxic substances," "hazardous waste" or "hazardous substance" under any Environmental Law.

Owner represents, warrants and agrees that, except as previously disclosed and acknowledged in writing:

(1) No Hazardous Substance has been, is or will be located, transported, manufactured, treated, refined, or handled by any person on, under or about the Property except in the ordinary course of business and in strict compliance with all applicable Environmental Law.

(2) Owner has not and shall not cause, contribute to or permit the release of any Hazardous Substance on the Property.

- (3) Owner shall immediately notify Bank if: (a) a release or threatened release of Hazardous Substance occurs on, under or about the Property or migrates or threatens to migrate from nearby property; or (b) there is a violation of any Environmental Law concerning the Property. In such an event, Owner shall take all necessary remedial action in accordance with any Environmental Law.
- (4) Owner has no knowledge of or reason to believe there is any pending or threatened investigation, claim, or proceeding of any kind relating to (a) any Hazardous Substance located on, under or about the Property or (b) any violation by Owner or any tenant of any Environmental Law. Owner shall immediately notify Bank in writing as soon as Owner has reason to believe there is any such pending or threatened investigation, claim, or proceeding. In such an event, Bank has the right, but not the

obligation, to participate in any such proceeding including the right to receive copies of any documents relating to such preceedings.

(5) Owner and every tenant have been, are and shall remain in full compliance with any applicable Environmental Law.

(8) There are no underground storage tanks, private dumps or open wells located on or under the Property and no such tank, dump or well shall be added unless Bank first agrees in writing.

(7) Owner will regularly inspect the Property, monitor the activities and operations on the Property, and confirm that all permits, licenses or approvals required by any applicable Environmental Law are obtained and compiled with.

(3) Owner will permit, or cause any tenant to permit, Bank or Bank's agent to enter and inspect the Property and review all records at any reasonable time to determine: (a) the existence, location and nature of any Hazardous Substance on, under or about the Property; (b) the existence, location, nature, and magnitude of any Hazardous Substance that has been released on, under or about the Property; (c) whether or not Owner and any tenant are in compliance with any applicable Environmental Law.

(9) Upon Bank's request, Owner agrees, at Owner's expense, to engage a qualified environmental engineer to prepare an environmental audit of the Property and to submit the results of such audit to Bank. The choice of the environmental engineer

who will perform such audit is subject to the approval of Bank.

(10) Bank has the right, but not the obligation, to perform any of Owner's obligations under this paragraph at Owner's expense.

(11) As a consequence of any breach of any representation, warranty or promise made in this paragraph, (a) Owner will indemnity and hold Bank and Bank's successors or assigns harmless from and against all losses, claims, demands, liabilities, damages, cleanup, response and remediation costs, penalties and expenses, including without limitation all costs of litigation and reasonable attorneys' fees, which Bank and Bank's successors or assigns may sustain; and (b) at Bank's discretion, Bank may release this Agreement and in return Owner will provide Bank with collaieral of at least equal value to the Property secured by this Agreement without prejudice to any of Bank's rights under this Agreement.

(12) Notwit standing any of the language contained in this Agreement to the contrary, the terms of this paragraph shall survive any foreclosure in satisfaction of any deed of trust, mortgage or any obligation regardless of any passage of title to Bank or any

disposition by B ank of any or all of the Property. Any claims and defenses to the contrary are hereby walved.

Bank's course of dealing, o Bank's forbearance from, or delay in, the exercise of any of Bank's rights, remedies, privileges or right to insist upon Owner's strict perior nance of any provisions contained in this Agreement, or other loan documents, shall not be construed as a waiver by Bank, unless any such wriver is in writing and is signed by Bank.

AMENDMENT. The provisions contained in this Agreen et I may not be amended, except through a written amendment which is signed by
