THIS MORTGAGE, ASSIGNMENT OF LEASES AND RENTS, SECURITY AGREEMENT AND FINANCING STATEMENT (heroin called "Marijage") is made as of Told Willy 199 12, by and between Standard Bank & Trust Company, not personally but as gustee under Trust Agreement dated September 27, 1990 and known as Trust No. 5070 ("Trust"), Anastasios Panagiotopoulos and Satarias Panagiotopoulos, (collectively, "Beneficiary" and together with Trust, and each of their respective successors and assigns, called "Mortgagor") in fever of St. Paul Federal Bank For Savings, a federal savings bank (herein, together with its successors and assigns, called the "Mortgagor").

- A. Note, Principal and Interest. GRANT

NOW, THEREFORE, for and in consideration of the recitals set forth above which are hereby incorporated, the Mortgages's making the Loan to Mortgager, the various agreements contained herein and in the Note and any Related Agreements, and other good and valuable consideration, the receipt and sufficiency of all of which are hereby acknowledged by Mortgager, and in order to secure the full, timely and proper payment of each and every one of the Liabilities and the performance of each and every one of the Obligations (provided, however, that the maximum amount to be secured by this Mortgage shall not exceed three times the Loan plus the total amount of all advances made by Mortgages to protect the Collateral and the security interest and lien created hereby), MORTGAGER MORTGAGES, WARRANTS, CONVEYS, TRANSFERS AND ASSIGNS TO MORTGAGES, AND CRANTS TO MORTGAGES AND ITS SUCCESSORS AND ASSIGNS FOREVER ALL OF THE COLLATERAL.

TO HAVE AND TO HOLD the Collateral unto Mortgagee forever, for the purposes and uses herein set forth, and Mortgager hereby expressly waives seel releases any and all right, benefit, privilege, advantage or exemption under and by virtue of any and all statutes and laws of the state or other jurisdiction in which the Real Estate is located providing for the exemption of homesteads from sale on execution or other wice.

AGREEMENT

I. COVENANTS AND AGREEMENTS OF MORTGAGOR.

Further to secure the payment of the Liabilium and the performance of the Obligations, Mortgagor hereby covenants and agrees with Mortgagee as follows:

- 1.1 Performance of Obligations. Mortgagor shall perform, observe and comply with all Obligations, including without limitation, all terms, covenants and conditions of the Note, the Mortgago and the Related Agreements.
- 1.2 Payment of Liabilities. - Payment of Taxes. Mortgagor will (i) pay before due all taxes and assessing ints, general or special, and any and all levies, claims, charges, expenses and liens, ordinary or extraordinary, governmental or non-povernmental, statutory or otherwise, due or to become due, that may be levied, assessed, made, imposed or charged on or against the Collateral or any property used in connection therewith; (ii) pay before due any tax or other charge on the interest or estate in lands greated or represented by this Mortgage or by any of the other Related Agreements, whether levied against Mortgagor or Mortgage or otherwise; and (iii) will submit to Mortgagee all receipts showing payment of all of such taxes, assessments and charges within this, or (30) days of its due date.
- 1.4 Funds for Taxes and insurance. In order to more fully protect the security of this Mortgage and in order to provide security to Mortgagee for the payment of the amounts required under Section 1.3 hereof, Mortgagee requires Mortgager to deposit with Mortgagee or its designee, at the time of each payment of an installment of interest or principal under the Note, an additional amount sufficient to discharge the obligations of Mortgager under Section 1.3 hereof as and when they become due. The determination of the amount payable and of the fractional part thereof to be deposited with Mortgagee shall be made by Mortgagee in its discretion based on the prior year's taxes and Mortgagee's estimate of the amount by which taxes can be expected to rise. If at any time within thirty (30) days prior to the due date of any of the obligations, the amounts then on deposit therefor shall be insufficient for the payment of such obligation in full, Mortgager shall, within seven (7) days after demand, deposit the amount of the deficiency with Mortgagee. If the amounts deposited are in excess of the actual obligations for which they were deposited, Mortgagee may refund any such excess, or, at its option, may hold the same and reduce proportionately the required monthly deposits for the ensuing year. Nothing herein contained shall be deemed to affect any right or remedy of Mortgagee under any other provision of this Mortgage or under any statute or rule of law to pay any such amount and to add the amount so paid to the Liabilities. All amounts held by Mortgagee or its designee shall be held not in trust and not as agent of Mortgager, and may be commingled with other funds held by Mortgagee or its designee, and said amounts shall not bear interest, and shall be applied to the

payment of the obligations in respect to which the amounts were deposited or, at the option of Mortgagee, to the payment of said obligations in such order or priority as Mortgagee shall determine. All amounts so deposited shall be held by Mortgagee or its designee as additional security for the Liabilities. Upon the occurrence of a Default, Mortgagee may, in its sole and absolute discretion and without regard to the adequacy of its security hereunder, apply such amounts or any portion thereof to any part of the Liabilities. Any such application of said amounts or any portion thereof to any Liabilities shall not be construed to cure or waive any Default or notice of Default hereunder or invalidate any set done pursuant to any such Default or notice. Mortgager shall deliver to Mortgagee all iax bills, assessment statements and statements for any other applicable obligations as soon as the same are received by Mortgager, and Mortgagee shall be entitled to roly thereupon and shall be entitled to pay such amounts. If Mortgagee sells or assigned, and Mortgage, Mortgagee shall have the right to transfer all amounts deposited under this Section to the purchaser or assigned, and Mortgagee shall thereupon be released and have no further liability hereunder for the application of such deposits, and Mortgagee shall look solely to such purchaser or assignee for such application and for all responsibility relating to such deposits. At any time after the occurrence of a Default, Mortgagee may, at its option, by written notice to Mortgagor require Mortgagor to make similar deposits to those set forth above for the payment of amounts required under Section 1.9 hereof, in which case all of the foregoing terms and Mortgagor shall immediately begin making such deposits in accordance herewith.

Mainta are and Repair. Mortgagor will not abandon the Premises; not do or suffer anything to be done which would depreciate or impair the velocial for the Collateral or the security of this Mortgage; not remove or denotish any of the improvements; pay promptly for all labor and instead for all construction, repairs and improvements to or on the Premises; not make any changes, additions or alterations to the Premises or the improvements except as required by any applicable governmental requirement or as otherwise approved in writing by Mortgagoe; maintain, preserve and keep the Personalty and the improvements in good, safe and insurable condition and repair and protoply make any needful and proper repairs, replacements, renewals, additions or substitutions required by wear, damago, obsolescence or designation; promptly restore and replace any of the improvements or Personalty which are destroyed or damaged; not commit, suffer or permit waste of any part of the Premises; and maintain all grounds and abutting streets and sidewalks in good and neat order and replic.

1.6 Transfer of Premises: Liens.

In determining whether or not to make the loan secured hereby. Mortgages and Beneficiary recognize that Mortgages is entitled to keep its loan portions at current interest rates by either making new loans at such rates or collecting assumption fees and/or increasing the interest rate on a loan. Mortgages and Beneficiary further recognize that any secondary or junior financing placed upon the Collateral: (a) may divert finds which would otherwise be used to pay the Liabilities; (b) could result in acceleration and forcelosure by any such junior encumbrance which would force Mortgages to take measures and incur expenses to protect its security; (c) would detract from the value of the Collateral should Mortgages come into possession thereof with the intention of selling the same; and (d) would impair Mortgages's right to recept a deed in lieu of forcelosure, as a forcelosure by Mortgages would be necessary to clear the title to the Premises.

- (vii) Such other insurance relating to the Collateral and the use and operation thereof, as Mortgagee may, from time to time, reasonably require, including, but not limited to, dramshop, products liability and workers' compensation insurance.

All insurance shall: (i) be carried with companies with a Best's rating of A or better, or otherwise acceptable to Mortgagee; (ii) be in form and content acceptable to Mortgagee; (iii) provide thirty (30) days' advance written notice to Mongagee given in the manner set forth herein before any cancellation, material modification or natice of non-renewal; and (iv) previde that no claims shall be paid thereunder without ten (10) days' advance written notice to Mortgagee in the manner set forth hervin. All physical damage policies and renewals shall contain a standard mortgagee clause naming Mortgagee and its successors and assigns, r. n ortgagee, which clause shall expressly state that any breach of any condition or warranty by Mortgagor shall not prejudice the rights of Mortgagor under such insurance, and a loss payable clause in favor of Mortgagoe for personal property, contents, inventory, equipment, loss of rents and business interruption. All liability policies and renewals shall name Mortgagoe and its successor and assigns as an additional insured. No additional parties shall appear in the mortgagoe or loss payable clause without Mortgagoe's prior written consent. All deductibles shall be in amounts acceptable to Mortgagoe. In the event of the foreelosure of this Mortgago or any other transfer of title to the Collateral in full or partial satisfaction of the Liabilities, all right, title and interest of Mortgagor in and to all insurance policies and renewals thereof then in force shall pass to such purchaser or grantee. Mortgagor authorizes and empowers Mortgagoe to effect insurance upon the Collateral in the amounts aforesaid, for a period covering the time from entry of a foreclosure of the said insurance and insuranc clause shall expressly state that any breach of any condition or warranty by Mortgagor shall not prejudice the rights of Mortgagoe decree to and including the date of sale, and if necessary therefor, to enteel any or all existing insurance policies. Any failure of Mortangor to provide the policies described in this Section 1.9 to Mortangec requires Mortangee to incur additional administrative and servicing expenses. Accordingly, Mortgagor agrees that in addition to any other remedy available to Mortgagoe hereunder and/or at law and in addition to any other administrative late fee and/or late fee due under any other section herein and/or the Note or the Related Agreements, an administrative late fee equal to the sum of(i) five percent (5%) times (ii) the amount of then applicable

Each insurance company is hereby authorized to make paymen of 100% of all such losses directly to Mortgagee alone. After deducting from such insurance proceeds any expenses incurred by Mori targe in the collection and settlement thereof, including without limitation attorneys' and adjusters' fees and charges, Mortgagee that apply the net proceeds to the Liabilities, in such order as Mortgagee may determine, or, at its sole and absolute discretion to the rest ration or repair of the Collateral in accordance with such terms, conditions and restrictions as Morigagee, in its sole and absolute discretion, may impose. Any surplus remaining after payment and satisfaction of the Liabilities shall be paid to Mortgagor. Mortgagor shall not be responsible for any failure to collect any insurance proceeds due under the terms of any policy regardless of the cause of each failure, except due to Mortgagee's gross negligence or wilful misconduct. If any material part of the Collateral is damaged or activitied and the loss is not adequately covered by insurance proceeds collected or in the process of collection, Mortgagor shall deposit, within ten (10) days of Mortgagoe's request therefor, the amount of the loss not so covered.
- 1.9.4 Proceeds of Rent and Rental Value and Business Interruption Insurance. m. DEFAULT

Each of the following shall constitute a default ("Default") hereunder (including, if Mortgagor consists of more than one person or entity, the occurrence of any of such events with respect to any one or more of such persons or entities):

- 2.1 Payment: Performance. Failure to make any payment of principal or interest or any other amount on the Note or any of the other Liabilities, when and as the same shall become due and payable, whether at maturity or by acceleration or otherwise and the continuation of such failure for ten (10) days after such due date. Default in the timely and proper performance of any of the other covenants or agreements of Mortgagor contained herein, and, except if the continued operation or safety of the Premises, or the lien hereof or the lien of any other security granted to Mortgagee or the value of the Collateral is immediately threatened or jeopardized, the continuation of such failure for thirty (30) days after written notice thereof is given Mortgagor by Mortgagee. A Default occurs under the Note or under any of the Related Agreements.

 - (2) public health risks:
 - (3) the environmental condition of the Premisca, or any portion thereof, or the contamination of any other property by Flazardous Material commuting from the Premises, including actual or alleged damage or injury to wildlife, blots, nir, surface or subsurface soil or water, wetlands or other natural resources; or
