II. Successors and Asigns Bound; Joint and Several Liability; Co-Signers. The covenants and agreements of this Security Instrument shall bind and benefit the successors and assigns of Lender and Borrower, subject to the provisions of paragraph 17. Borrower's covenants and agreements shall be joint and several. Any Borrower who vo-signs this Security Instrument but does not execute the Note: (a) is co-signing this Security Instrument only to making green and convey that Borrower's interest in the Property under the terms of this Security Instrument: (b) is not personally obligated to pay any sums secured by this Security Instrument; and (c) agrees that Lender and any other Borrower may agree to extend, modify, forbear or make any accommodations with regard to the terms of this Security Instrument or the Note without that Borrower's consent.

Loan Charges. If the loan secured by this Security Instrument is subject to a law which sets maximum loan charges, and that law is finally interpreted so that the interest or other loan charges collected or to be collected in connection with the loan exceed the permitted limits, then: (a) any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limit; and (b) any sums already collected from Borrower which exceed permitted (mits will be refunded to Borrower. Lender may choose to make this refund by reducing the principal owed under the Note or by making a direct p symeth to Borrower. 13. Legislation Affecting Lender's Rights. If Lender exercises this option, Lender shall

14. Notices. Any notice to Borrower provided for in this Security Instrument shall be given by delivering it or by mailing it by first class mail unless applicable law requires use of another method.
