every person relying upon or claiming under any such conveyance, lease or other instrument, (a) that at the time of the

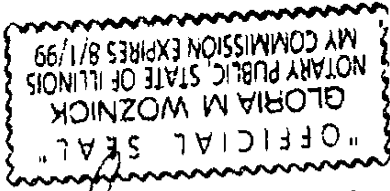
