The interest of each and every beneficiary hereunder and of all persons claiming under them or any of them shall be only in the earnings, avails and proceeds ansing from the sale or other disposition of said real estate, and such interest is hereby fer at all to be personal property, and no beneficiary hereunder shall have any little or interest, legal or equilable, in or to said real estate as such but only an interest in the earnings, avails and proceeds thereof as aforesaid.

If the title to any of the above lands is now or hereafter registered, the Registrar of Titles is hereby directed not to legister or note in the certificate of title or duplicate thereof, or memorial, the words "in trust" or "upon condition," or "with finitations," or words of similar import, in accordance with the statute in such cases made and provided.
