- 1. It is hereby acknowledged that as of the date hereof the present principal values due under the Note heretofore referred to is One Hundred Twenty Nine Thousand Dix Hundred Seventeen Dollars and 29/100 (\$129,617.29) comprised of the principal balance as of January 1, 1996 of \$127,701.76 plus accrued interest through March 1, 1996 of \$1,915.53. Escrow payments are not included in this increase.
- Commencing April 1, 1996, and on the first of each month thereafter, Niortgagor shall pay Two Thousand Six Hundred Five Dollars and 60/100 (\$2,605.60). The principal plus accrued interest is \$1,912.60 with escrow payment subject to change of \$693.00. A final payment of all principal, accrued interest and any other due charges will become due if not sooner paid, on February 1, 2004.
