Agreement be and the same is hereby modified to show that the current principal balance is \$384,745.08 with a monthly principal and interest payment of \$4,668.02 beginning 9/5/95 and continuing on the fifth day of each consecutive month at a fixed rate of interest of 8.00% with the final payment of all accrued principal and interest due on 8/05/2000.

Assignment of Rents and Ext. and Mod. Agreement shall remain unchanged and in full force and effect for and during said period except only as herein specifically modified, and further that in event of default in the payment of principal or interest due under said Note as herein modified, or in the event of failure to perform any and all of the agreements contained in said Mortgage & Assignment of Rents and Ext. and Mod. Agreement as herein modified, the entire amount of unpaid principal and interest shall at the option of the holder thereof become immediately due and payable without notice or demand; that all the rights and obligations under said Note and Mortgage & Assignment of Rents and Ext. and Mod.
