AN ORDINANCE AMENDING VILLAGE ORDINANCE NUMBER 92-8-Z-2320 APPROVING MODIFICATIONS TO THE PREVIOUSLY APPROVED SPECIAL USE PERMIT FOR A FAST-FOOD RESTAURANT WITH A DRIVE-THRU FACILITY AT 3710 TOUHY AVENUE, SKOKIE, ILLINOIS IN AN M-3 INDUSTRY DISTRICT

WHEREAS, or August 17,1992, the Mayor and Board of Trustees of the Village of Skokie adopted Village Ordinance Number 92-8-Z-2320 granting a special use permit for the operation of a fast food resignment with a drive-thru facility at the property legally described as follows:

- That condition number 2 (the Revised Landscape Plan dated July 1, 1992) be amended to reference the additional landscaping depicted on the November 14, 1995 Amended Site Plan.
- 3. That condition number 3 be amended to reflect amended north (rear) and west (left) elevations to the restaurant, modifying the previously approved elevations dated May 8, 1992, with revisions dated November 14, 1995.
