



LEGAL DESCRIPTION

PARCEL 1:

THE EASTERLY HALF OF LOT 1 BEING THAT PART OF SAID LOT 1 LYING NORTH EASTERLY OF A LINE DRAWN MIDWAY BETWEEN THE EASTERLY AND WESTERLY LINE OF SAID LOT 1, ALSO THE NORTH EASTERLY QUARTER OF LOT 2, BEING THAT PART OF SAID LOT 2 LYING NORTH EASTERLY OF A LINE DRAWN MIDWAY BETWEEN THE EASTERLY AND WESTERLY LINE OF SAID LOT 2 AND NORTH WESTERLY OF A LINE DRAWN MIDWAY BETWEEN THE NORTH WESTERLY AND SOUTH EASTERLY LINES OF SAID LOT 2 ALL, IN BLOCK 9 IN THE VILLAGE OF GLENCOE IN FRACTIONAL SECTION 7, TOWNSHIP 42 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

AND ALSO PARCEL 2:
