ORDER FOR POSSESSION

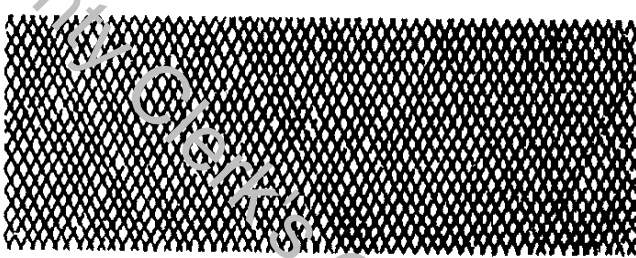

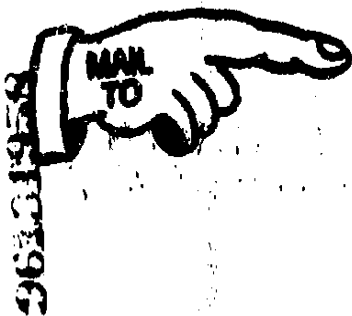
