MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE IS DATED MAY 2P, 1995, BETWEEN Raymand Seungryong Kim and Kang J. Kim, a/k/a Connie K. Kim, husband and wife (referred to below as "Grantor"), whose address is 6145 N. MORTGAGE. Grantor and Lender have entered into a mortgage dated May 28, 1993 (the "Mortgage").
