
The following corrections are hereby made to the plat noted above:

1. The West line of former Lot 71 in Golf Greenwood Gardens Subdivision is identified on the plat as being " N 00°00'00" W 251.27' " and is hereby changed to read " N 02°10'44" E 251.27' " .
2. The north line of proposed lot 1 is identified on the plat as " N 90°00'00" E 299.14' " and is hereby revised to read "N 90°00'00" E 297.24' " .
3. The South west line of the former lot 71 and a portion of former lot 70 is identified on the plat as being S 89°56'26" W 104.25' " and is hereby changed to read " S 89°56'26" W 112.09' " .
4. The former interior lot lines between lots 69, 70 and 71 were not graphically drawn to scale on the plat and shall be corrected. As well, the north lot line dimensions for each lot were shown to be "99.03' " , they shall be corrected to show "99.07' " .
5. The building set back lines shown on the plat and identified as " 50 foot building line per Golf Greenwood Gardens Subdivision" are hereby removed. According to the original plat of Golf Greenwood Gardens Subdivision, recorded June 6, 1939 as document no. 12322209. Item "A" under property restrictions states that " the following covenants and restrictions are to run with the land and shall be binding on all parties claiming under them until January, 1, 1964."

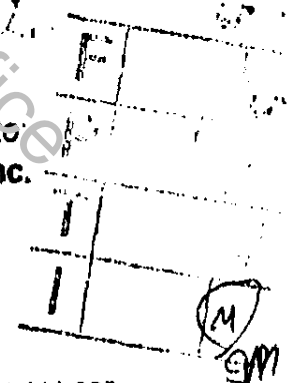

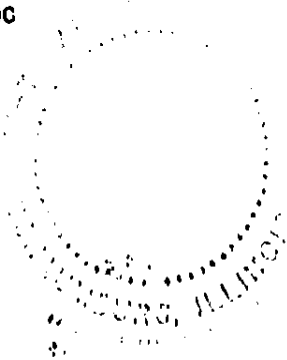
