All replacements and additions shall also be covered by this Security Instrument. All of the foregoing is referred to in this Security Instrument as the "Property."

BORROWER COVENANTS that Borrower is inwfully seised of the estate hereby convered and has the right to mortgage, grant and convey the Property and that the Property is unencumbered, except for encumbrance, of record. 15. Governing Law; Severability. This Security Instrument shall be governed by federal law and the law of the invisition in which the Property is located.
