an additional loan in the amount of Five Hundred Thousand and 00/100 Dollars (\$500,000.00)
an extension of the maturity date of the Note from December 2, 1996 to March 2, 1997
D. Bank is willing to grant such request pursuant to the terms and provisions of this Agreement and the Promissory Note dated
February 23, 1996 in the principal sum of ** Dollars (\$2,295,000.00)
which bears interest due and payable at the rate specified therein ("Replacement Note").

NOW, THEREFORE, in consideration of the above Recitals, the parties hereto do hereby acknowledge and agree as follows:

- 1. Mortgagor (X) and Guarantor(s) does/do hereby acknowledge that the Mortgage (Assignment of Rents), (X) Guaranty)
and other applicable Security Documents are in full force and effect.
2. The Mortgage, (Assignment of Rents) and other Security Documents are hereby modified to provide that such instruments
continue as collateral security for repayment of the Replacement Note.

In the event the Mortgagor executing this Agreement is an Illinois land trust, this Agreement is executed by the Mortgagor, not personally but as Trustee aforesaid in the exercise of the power and authority conferred upon and vested in it as such Trustee and the Mortgagor hereby warrants that it possesses full power and authority to execute this instrument and it is expressly understood and agreed that nothing contained herein or in the Replacement Note shall be construed as creating any liability on the Mortgagor personally to pay the Replacement Note or any interest, late charge or premium that may accrue thereon, or any indebtedness secured by this Agreement or the security documents referred to herein, or to perform any covenant, either express or implied herein contained, all such liability, if any, being expressly waived by Bank and by every person now or hereafter claiming any right or security hereunder, and that so far as Mortgagor is personally concerned, the legal holder or holders of the Note or Replacement Note and owner or owners of any indebtedness secured hereby shall look solely to the Premises and Collateral referred to herein and to any other security given at any time to secure the payment thereof.
