One family house located at 6000 W. Nelson Street in Chicago, Illinois 60634, see attached "Exhibit A".

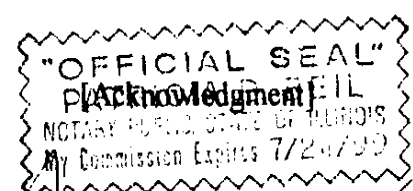
Together with all the tenements, hereditary, and appurtenances thereunto belonging, and the reversions, remainders, rents, issues, and profits thereof.

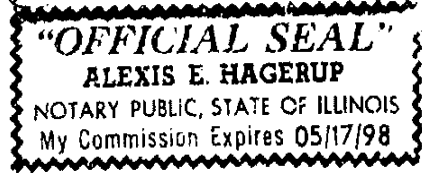

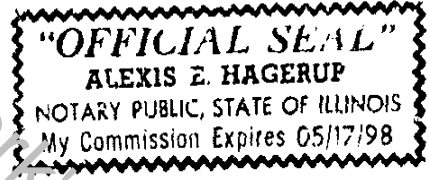
