ORDER

THIS CASE, coming on to be heard on the application of the BOARD OF LOCAL IMPROVEMENTS OF THE VILLAGE OF ARLINGTON HEIGHTS, COOK COUNTY, ILLINOIS, for this Court to amend the Order Confirming Final Cost, Conformance of Work to Original Ordinance and Confirming Assessment Roll, as Abated, entered by this Court on December 11, 1995 (the "Prior Order") and the Court being advised in the premises,

IT IS HEREBY ORDERED that the Prior Order is hereby amended as follows:

(1) The reference in paragraph (2) of the Prior Order to the project as being described in Ordinance No. 94-082 adopted on September 19, 1994 by the President and Board of Trustees of the Village of Arlington Heights, Illinois, shall be amended to refer to the project described in Ordinance No. 93-057 adopted on June 21, 1993 by the President and Board of Trustees of the Village of Arlington Heights, Illinois.

(2) The assessment confirmed against lot 4 in in C.A. Goelz's Arlington Heights Gardens, a subdivision in the northeast one-quarter of Section 20-42-11, permanent index number 03-20-202-009, is voided because the owner of said lot installed the required sidewalk improvements on his lot prior to the confirmation of the Assessment Roll in this case, and this Court ordered said lot deleted from the Assessment Roll by the order of this Court entered June 22, 1994, and said lot should have been deleted from the Assessment Roll confirmed by the Prior Order.

(3) The assessment confirmed against lot 5 in in C.A. Goelz's Arlington Heights Gardens, a subdivision in the northeast one-quarter of Section 20-42-11, permanent index number 03-20-204-013, is voided because the owner of said lot installed the required sidewalk improvements on his lot prior to the confirmation of the Assessment Roll in this case, but the Village of Arlington Heights inadvertently failed to so notify this Court and request the deletion of said property from the Assessment Roll, and said lot should have been deleted from the Assessment Roll confirmed by the Prior Order.

(4) The assessment against private properties benefitted by the local improvement and the judgement of confirmation shall be against each lot, block, tract or parcel of land as described in and for the amount set forth in the abated Assessment Roll attached to the Prior Order, except there shall be no assessment against the two lots deleted from said roll by this Order; and the total assessment to be paid by the Village of Arlington Heights as a public improvement shall remain at \$301,821.70.

(5) The warrant in this matter having already been issued, based on the abated Assessment Roll confirmed pursuant to the Prior Order, the collector for the Village of Arlington Heights is hereby directed not to collect any assessment from the owners of the above described lots for which the judgement of confirmation is hereby voided.

(6) Except as provided in this Order, the Prior Order shall remain unmodified and in full force and effect.
