The Credit Agreement has tiered rates and the rate that applies to Borrower depends on Borrower's outstanding account balance. The interest rate to be applied to the outstanding account balance shall be at a rate 1,000 percentage points above the index for balances of \$49,999.99 and under and at a rate equal to the index for balances of \$50,000.00 and above, subject however to the following maximum rate.
