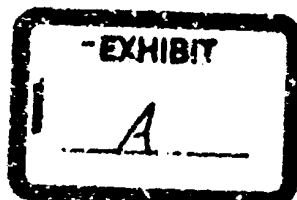

That part of a parcel of land in the Northeast Quarter of Fractional Section 14, Township 37 North, Range 11 East of the Third Principal Meridian, in Cook County, Illinois; lying north of the north line of the Calumet Sag Channel and further described as follows:

Commencing at the northeast corner of the Northeast Quarter of said Fractional Section 14; thence on an assumed bearing of South 88 degrees 28 minutes 21 seconds West along the north line of said Northeast Quarter 1812.47 feet to the westerly right of way line of Illinois Route 63 per Dedication recorded June 11, 1937 as Document Number 12010932; thence South 30 degrees 30 minutes 43 seconds East along said westerly right of way line and the southerly extension thereof 2070.52 feet to the point of beginning; thence continuing South 30 degrees 30 minutes 43 seconds East along said westerly right of way line (extended southerly) 10.58 feet to a line that lies parallel with and 35.00 feet southeasterly from the centerline of the Illinois Central Railroad Company's northbound main track; thence North 40 degrees 23 minutes 50 seconds East along said parallel line 211.64 feet to the easterly right of way line of said Illinois Route 63 (extended southerly) per Dedication recorded June 11, 1937 as Document Number 12010918; thence North 30 degrees 30 minutes 43 seconds West along the southerly extension of said easterly right of way line 10.58 feet to a line that lies parallel with and 25.00 feet southeasterly from the centerline of said Illinois Central Railroad Company's northbound main track; thence South 40 degrees 23 minutes 50 seconds West along said parallel line 211.64 feet to the point of beginning.

Said parcel containing 0.049 Acres, more or less, of which 0.013 Acres has previously dedicated or used for public highway purposes.
