### RIGHT OF

THIS AGREEMENT (this "Agreement") made this <u>little</u> day of <u>little</u>, 1996, by and between EDWARD and PATRICIA KRASE, lilinois (collectively the "Owner") and the VILLAGE OF NORTHBROOK (the "Village"),

#### WITNESSETH

WHEREAS, the Owner is the owner of the fee simple interest in that certain real estate located at 3105 Walters Avenue, Northbrook, Illinois, which property is legally described on Exhibit A attached hereto and made a part hereof (the "Subject Property"); and

WHZPCAS, the Village is interested in purchasing the Subject Property at a future date; and

WHEREAS the Owner desires to grant a right of first offer to the Village and the Village desires to accept such right as to the Subject Property on the terms and conditions contained herein;

NOW THEREFORE, for and in consideration of TEN DOLLARS (\$10.00) and other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

- 1. Right of First Offer. Pror to any sale of the Subject Property, and prior to contracting to sell the Subject Property, the Owner shall by written notice to the Village (the "Offer"), offer the Subject Property for sale to the Village in the manner nereinafter set forth, and the Village shall have a period of 30 days following receipt of the Offer in which to accept or reject the Offer, by written notice to the Owner (the "Response") sent within said 30 day period. In the event that the Village fails to send the Response within said 30 day period, the Village shall be deemed to have rejected the Offer. Following acceptance or rejection of the Offer, the Subject Property may be send by the Owner only in accordance with the provisions hereinafter set forth.
  - 2. The Otter. The Offer shall contain the following Information:
- (a) The purchase price (including, without limitation, all cash payments and other consideration and the terms of payment thereof) (the "Purchase Price") for "A Subject Property; and
- (b) All other material terms and conditions applicable to the proposed sale of the Subject Property.
- 3. Acceptance of Offer. If the Village accepts the Offer by timely sending the desponse, the Subject Property shall thereafter be sold by the Owner and purchased by the Village at a closing (the "Closing") to be held at a place and on a date specified in the Offer, which date shall be not earlier than 30 days following expiration of the 30 day period described in Section 1 hereof. The Closing shall be in accordance with the customs then prevailing in Chicago, tilinois.
- A. <u>Rejection of Offer.</u> If the Village rejects the Offer, the Owner shall be free, during the 120 day period following expiration of the 30 day period described in Section 1 hereof, to offer, contract and otherwise make available for sale the Subject Property and to sell the Subject Property on the terms described in the Offer; provided that, if the Subject Property has not been sold in accordance with the Offer during said 120 day period, all of the provisions of Section 1 through 3 hereof shall again be applicable to any sale or attempted sale of all or any portion of the Subject Property.

5. <u>Notices.</u> Any notice, demand, request or other communication which may or shall be given or served pursuant to this Agreement shall be in writing and shall be either (a) personally delivered, (b) sent by U.S. mail, certified or registered mail, return receipt requested, postage prepaid, and addressed as follows, unless otherwise requested by notice provided in accordance with the terms hereof:

6. <u>Recurriation</u>. Either party may record this Agreement against the Subject Property in the Office of the Cook County Recorder of Deeds.

7. <u>Successors and Assigns.</u> This Agreement is and shall be binding on the heirs, executors, successors, transferees and assigns of both parties.
