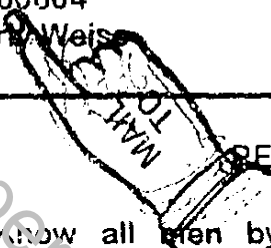

## RELEASE DEED





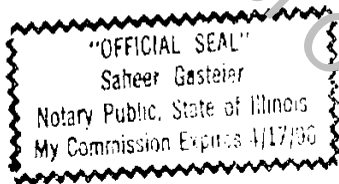
