LEGAL DESCRIPTION

PARCEL 1: Unit No. 49 as shown and identified on the survey of that part of tract of land described as follows: That part of Lot 1 in Kenney's Huntington, being a subdivision of part of the East 1/2 of Section 14, Township 41 North, Range 11 East of the Third Principal Meridian, as described as follows:
