TOGETHER with all improvements, tenements, easements, fixtures, and appurtenances thereto belonging, and all rents, issues, and profits thereof for so long and during all such times as Mortgagors may be entitled thereto (which are pledged primarily and on a parity with said real estate and not secondarily) and all apparatus, confiment or articles not or hereafter therein or the row used to supply heat, gas, air conditioning, water, light, power, refrigeration (whether single units or centralis controlled), and ventilation, including (without restricting the foregoing), screens, window shades, storm doors and windows, floor coverings, inador beds, awnings, stoves, and water heaters. - 1. Mortgagors shall (1) promptly repair, restore, or rebaild any buildings or improvements which may become damaged or be destroyed: (2) keep said premises in good condition and repair, without waste and free from mechanic's or other liens or claims not expressly subordinated to the lien thereof: (3) pay when due any indebtedness which may be seened by a lien or charge on the premises superior to the lien hereof, and apon request exhibit satisfactory evidence of the discharge of such prior lien to the Mortgagee; (4) complete within a reasonable time any building or buildings now or at any time in process of creetion upon said gremises; (5) comply with all requirements of taw or minicipal ordinances with respect to the premises and the use thereof; (6) make an material alterations in said premises except as required by law or municipal ordinance.
- 2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall upon written request, furnish to the Mortgagee duplicate receipts therefor. - 4. If, by the laws of the United States of America or of any state having jurisdiction in the premises, any tax is due or becomes due in respect of the issuance of the note hereby secured, the Mortgagors covenant and agree to pay such tax in the manner required by any such law. The Mortgagors further covenant to hold harmless and agree to
