SUBORDINATION AGREEMENT

- That the Bank covenants and consents that the lien of its Mortgage shall be subject and subordinate to the lien of Mortgagee's mortgage dated 4-13-16 reflecting and securing the loan made by Mortgagee to Borrowers, in the amount of One Hundred Sixty-Two Thousand and No/100 Dollars, and to all renewals, extensions or replacements of said mortgage; and
- II. That this Agreement shall be binding upon and shall inure to the benefit of Mortgagee, its successors and assigns.
