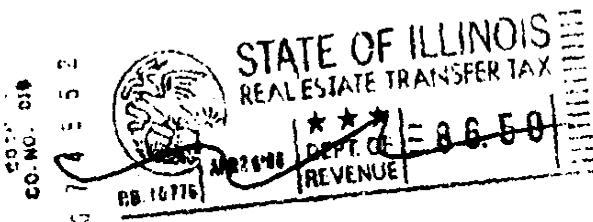

EXHIBIT A

PARCEL 1:
