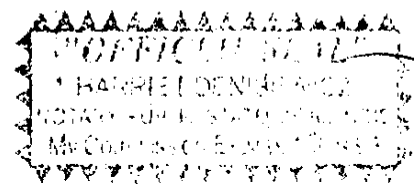

## EXHIBIT A

### PARCEL 1:
