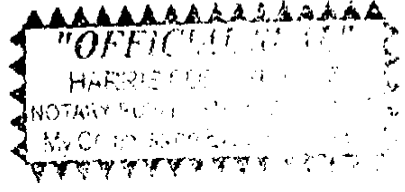

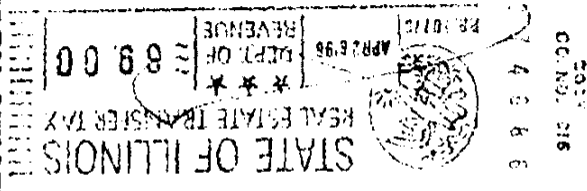

## EXHIBIT A
