Together With all the improvements now or hereafter erected on the property, and all easements, rights appurtenances, rents, royalties, minerals, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or fiereafter attached to the property covered by this Mortgage; and all of the foregoing, together with the said property (or the leasehold estate if this Mortgage is on a leasehold) are herein referred to as the "Property".

Borrower Covenants the Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property; and that the Property is unencumbered except for encumberances of record. Borrower warrants and will defend generally the title to the Property against all claims and demands, subject to any encumberances of record.

Covenants. Borrower covenants and agrees as follows:

- 1. Payment of Principal and Interest. Borrower shall promptly pay when due the principal of and interest on the indebtedness incurred pursuant to the Note, together with any fees and charges provided in the Note and Agreement.
- 2. Application of Payments. Unless aplilicable law provides otherwise, all payments received by Lender under paragraph 1 hereofshall be applied by Lender first in payment of amounts recoverable by Lender under this Mortgage, then to interest, fees, charges, and principal pursuant to the terms of the Agreement.
- 3. Charges; Liens. Borrower shall pay or cause to be paid all taxes, assessments, and other charges, fines, and impositions attributable to the Property that may attain priority over this Mortgage, leasehold payments or ground rents, if any, and all payments due under any mortgage disclosed by the title insurance policy insuring the Lender's interest in the Property(the "First Mortgage"), if any. Upon Lender's request, Borrower shall promptly furnish to Lender receipts evidencing payments of amounts discurded this paragraph. Borrower shall promptly discharge any lien that has priority over this Mortgage, except the lien of the First Mortgage; provided that Borrower shall not be required to discharge any such lien so long as Borrower shall, in a manner acceptable to Lender, agree in writing to the payment of the obligation secured by such lien or contest or defend enforcement of such lien in legal proceedings which I Lender's opinion operate to prevent the enforcement of the lien or for entire of the Property or any part thereof.

4. Hazard Insurance. Borrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included withir. The term "extended coverage", and such other hazards as Lender may require and in such amounts and for such periods as Lender may require; provided that Lender shall not require that the amount of such coverage exceed that amount of coverage are juired to pay the total amount secured by this Mortgape, taking prior liens and co-insurance into account.

The insurance carrier providing the insurance (ne) be chosen by Borrower and approved by the Lender (which approval shall not be unreasonably withheld). All premiums or incurance policies shall be paid in a timely manner. All insurance policies and renewals thereof shall be in form acceptable to Lender and shall include a standard mortgage clause in favor of and in form acceptable to Lender. Borrower shall promottly furnish to Lender all renewal notices and all receipts for paid primitings. In the event of loss, Borrower shall give prompt notice to the insurance carrier and Lender. Lender may make

primiums. In the event of loss, Borrower shall give prompt notice to the insurance carrier and Lender. Lender may make proof of loss if not made promptly by Borrower.

Unless Lender and Borrower otherwise agree in writing, insurance proceeds shall be applied to restoration or repair of the Property damaged, provided such restoration or repair is economically feasible and the security of this Mortgage is not impaired. If such restoration or repair is not economically feasible or if the security of this Mortgage would be impaired, the insurance proceeds shall be applied to the sums secured by this Mortgage, with the excess, if any, paid to Borrower, if the Property is abandoned by the Borrower, or if Borrower falls to respond to Lender within 30 days from the date the notice is malled by Lender to Borrower that the insurance carrier offers to settle a claim for the insurance benifits, Lender is authorized to collect and apply the insurance proceeds at Lender's option either to restoration or repair of the Property or to the sums secured by this Mortgage.

Unless Lender and Borrower otherwise agree in writing, any such application of proceeds to principal shall not extend or postpone the due date of the payments due under the Note and Agreement or charge the amount of such payments. If under paragraph 16 hereof, the Property is acquired by Lender, all right, title, and into a significant of the acquisition shall pass to Lender tot he extent of the sums secured by this Mortgage immediately prior to such acquistion.

- 5. Preservation and Maintenance of Property; Leaseholds; Condominiums; Planned Unit Devolopments. Borrower shall keep the Property in good repair and shall not commit waste or permit impairment or deterioration of the Property and shall comply with provisions of any lease if this Mortgage is on a leasehold. If this Mortgage is on a unit in a condominium or planned unit development, Borrower shall perform all of Borrower's obligations under the declaration of covenants creatling or governing the condominium or planned unit development, the bylaws and regulations of the condominium or planned unit development, and constituent documents. - 6. Protection of Lender's Security. If Borrower fails to perform the covenants and agreements contained in this Mortgage, or if any action or proceeding is commenced that materially affects Lender's interest in the Property, including, but not ilmited to, any proceeding by or on behalf of a prior mortgagee, eminent domain, insolvency, code enforcement, or arrangements or proceedings involving a bankrupt or decedent, then Lender, at Lender's option, may make such appearances, disburse such sums and take such action as is necessary to protect Lender's interest, including but not limited to, disbursement of reasonable attorney's fees and entry upon the Property to make repairs.

8. Condemnation. The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for conveyance in lieu of condemnation, are hereby assigned and shall be paid to Lender. In event of a total taking of the Property, the proceeds shall be applied to the sums secured by the Mortgage, with the excess, if any, paid to Borrower. In the event of a partial taking of the Property, unless aborrower and Lender otherwise agree in writing, the sums secured by this Mortgage shall be reduced by the amount of amount of the sums secured by this Mortgage immediately before taking, divided by (b) the fair market value of the Property immediately before the taking. Any balance shall be paid to the Borrower

If the Property is abandoned by the Borrower, or, if, after notice by the Lender to Borrower that the condemnor has offered to make an award or settle a claim for damages, Borrower fails to respond to Lender within 30 days after the date such notice is mailed. Lender is authorized to collect and apply the proceeds, at Lender's option, either to restoration or repair of the Property or to the sums secured by this Mortgage, whether or not yet due. Unless Lender and Borrower otherwise agree in writing, any such application of proceeds to principal shall not extend or postpone the due date of the amount due under the Note or Agreement or change the amount of such payments.

- 9. Borrower Not Released. No extension of the time for payment or modification of any term of the Note, the Agreement or this Mortgage granted by Lender to any successor in interest of the Borrower shall operate to release, in any manner, the liability of the original Porrower and Borrower's successors in interest. Lender shall not be required to commence proceedings against successor or refuse to extend time for payment or otherwise modify any term of the Note, the Agreement, or this Morcage, by reason of any demand made by the original Borrower or successor in interest.
- 10. Forbearance by Lender Not a Waiver. Any forbearance by Lender in exercising any right or remedy shall not be a waiver of or preclude the exercise of any right or remedy.
- 11. Successors and assigns bound; Joint and Several Liability; Captions. The covenants and agreements herein contained shall bind, and the roghts nereunder shall inure to the respective successors and assigns of Lender and Borrower. All covenants and agreements of Borrover shall be joint and several. The captions and headings of the paragraphs of this Mortgage are for convenience only and are not to be used to interpret or define the provisions hereof.
- 12. Notice. Except for any notice required under applicable law to be given in any manner, (a) any notice to Borrower provided for in this Mortgage shall be given by mulling such notice by certified mail addressed to Borrower at the Property Address or to such other address as Borrower may resignate by notice to Lender as provided herein, and (b) any notice to Lender's address stated herein or to such other address as Lender may designate by notice to Borrower provided herein. Any notice provided for in this Mortgage shall be deemed to have been given to Borrówer or Lender when given in the manner designated herein.
- 13. Governing Law; Severability. This Mortgage shall be governed by the laws of Illinois. In the event that any provision or clause of this Mortgage, the Note or the Agreement conflicts with applicable law, such conflict shall not affect the other provisions thereof which can be given effect without the conflicting provisions. To this end the provisions of the Note, the Agreement, and this Mortgage are declared severable.
- 14. Transfer of Property. To the extend permitted by law, if all or any part of the Property or any interest therein, including without limitation any beneficial interest in any trust holding title to the Property, is sold or transferred by Borrower without Lender's prior consent, Lender may, at Lender's option, declare all sums sourced by this Mortgage to be immediately due and payable.
- 15. Hevolving Credit Loan. This Mortgage is given to secure a revolving credit loan as authorized by Section 5d of the illinois Banking Act (Ill. Rev. Stat., Ch. 17, par. 312.3) and shall secure not only presently existing in debtedness under the agreement but also future advances, whether such advances are obligatory or to be made at the antion of the Lender, or otherwise, as are made within 10 years from the date hereof, to the same extent as if such future advances were made on the date of the execution of this Mortgage, although there may be no more advance made at the time of execution of this Mortgage and although there may be no indebtedness outstanding at the time any advance is made. The lien of this Mortgage shall be valid as to all indebtedness secured hereby, including future advances, from the time of its filling for record in the recorder's or registrar's office of the county in which the Property is located. The total amount of indebtedness secured hereby may increase or decrease from time to time, but the total unpaid balance secured hereby at any one time shall not exceed the Credit Limit, plus interest thereon, and any disbursements made for payment of taxes, special assessments, or insurance on the Property and interest on such disbursements. This Mortgage shall be valid and have priority over all subsequent liens and incumberances including statutory liens, excepting solely taxes and assessments levied on the Property given priority by law. levied on the Property given priority by law.
- 16. Acceleration; Remedies. Lender shall be entitled to collect in such proceeding all expenses of foreclosure, including, but not limited to, reasonable attorney's fees, and costs of documentary evidence, abstracts, and the title reports.
