On the 4th day of November, 1994, said party was the owner of or had an interest in the following described real estate situated in the Village of Ford Heights, Bloom Township, Cook County, Illinois, and legally described as follows:

Lots 20 and 21 in Block 1 in Thomas, Cheney and Waugh's Third Addition to Chicago Heights, being a Subdivision of the East ½ of the Southwest ¼ of Section 23, Township 25 North, Range 14 East of the Third Principal Meridian, in Cook County, Illinois.



On or about November 4, 1994, the Village of Ford Heights filed in the Circuit Court of Cook County a suit to abate the nuisance on the above-described real estate, being case number 94M6-5785, and thereafter, on the 23rd day of January, 1995, the Honorable Patrick J. Grossi, one of the Judges of the Circuit Court of Cook County, did enter a Decree authorizing the directing the Claimant herein to demolish the buildings and clean up the premises situated upon the above-described real estate. Chapter 24 of the Illinois Revised Statutes, Chapter 11-31-1, as amended, authorizes reimbursement for costs spent in the demolition of said buildings, and thereafter the Village of Ford Heights did secure the demolition of said structures and the clean-up of said premises on or about the 11th day of September, 1995, and the Village of Ford Heights, in securing the demolition of said buildings, did cause to be furnished labor and materials pursuant to a contract.

The said owner is entitled to no credits on account thereof and there is unpaid and owing to the Claimant, the Village of Ford Heights, on account thereof, the sum of THREE THOUSAND TWO HUNDRED SEVENTY-EIGHT AND 36/100 DOLLARS (\$3,278.36), for which, with interest at the statutory rate, the Claimant claims a lien on said land.
