WHEREAS. heretofore been recorded

Declaration Of Condominum Ownership For Heritage II Condominium Association, Phase II, (hereinafter referred to as "Declaration"), which Declaration was recorded in the Office of the Recorder of Deeds, Cook County, Illinois on September 25, 1991, as Document No. 91497369.

WHEREAS, said Declaration contains in it in Article IX, Section 9.02, a provision for amendment which provides as follows:

"9.02 AMENDMENT BY OWNERS. Subject to the provisions of Section 10.01 and Article X, and except as otherwise provided in Sections 5.06 and 5.07 and the Act, the provisions of this Declaration may be amended, modified, enlarged or otherwise changed in whole or in part by the affirmative vote of Voting Members in whole or in part by the affirmative vote of Voting Members (either in person or by proxy) for Unit Ownerships representing at least 75% of the Undivided Interests or by an instrument executed by Owners of Unit Ownerships representing at least 75% of the Undivided Interests, except that (i) the provisions relating to the rights of Trustee or Developer may be amended only with the written consent of the Developer and (ii) the provisions of Article IX and the provisions of this Article may be amended only with the written consent of all Owners. No amendment shall become effective until recorded."

WHEREAS, on or about March 31, 1993, a Second Amendment To Declaration was recorded with the Recorder of Cook County, Illinois as Document 93234690, and said Second Amendment, among other things, purported to amend the Exhibit "D" of the Declaration; and

WHEREAS, Exhibit "D" recorded as part of the Second Amendment to the Declaration purported to divide 100% of the ownership interests in the common elements among the Unit Owners; and

WHEREAS, Exhibit "D" recorded as part of the Second Amendment to the Declaration contained mathematical errors in the computation of the percentage of interest that each Unit Owner shall have in the common areas; and
