

### 33. LENDER'S RIGATA IN BORROWER FAILS TO KEEP PROMISES AND AGREEMENTS

The text of Covenant 17 of this Mortgage is deleted and replaced with the following:

Upon Borrower's breach of rey covenant or agreement of Borrower in this Mortgage, including the covenants to pay when due any Sums Secured by this Mortgage, or any simultaneous or subsequent agreement between Borrower and Lender relating to this transaction, Lender, at Lender's option, may declare all of the Sums Secured by this Mortgage to be immediately due and payable without notice or demand ("Immediate Payment In Full").


### 43. NO WAIVER; CONFORMITY TO LAW
