EXHIBIT A - LEGAL DESCRIPTION

PARCEL I:

UNIT 14-42-L IN PRINCETON CLUB TOWNE VILLAS CONDOMINIUM, AS DELINEATED ON A SURVEY OF THE FOLLOWING DESCRIBED REAL ESTATE:

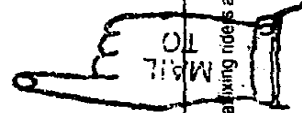
