5. Hazard or Property Insurance. Sorrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage" and any other hazards, including floods or flooding, for which Lender requires insurance. THIS CONDOMINIUM RIDER is made this 3 r d day of N a y . 1996 , and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Security Deed (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure Borrower's Note to COVENANT NORTGAGE CORPORATION

(the "Lender") of the same date and covering the Property described in the Security Instrument and located at:

The Property Included unit in, together with an undivided interest in the common elements of, a condominium project sown as:

(the "Condominium Project"). If the owners association or other entity which acts for the Condominium Project (the "Owners Association") holds title to property for the benefit or use of its members or shareholders, the Property also includes Corrower's interest in the Owners Association and the uses, proceeds and benefits of Borrower's interest.

(ii) Borrower's obligation under Uniform Covenant 5 to maintain nazaro insurance coverage on the Property is deemed satisfied to the extent that the required coverage is provided by the Coverage Sassociation policy.

Borrower shall give Lender prompt notice of any lapse in required hazard insurance coverege.

E. Lender's Prior Consent. Borrower shall not, except after notice to Lender and with Lender's prior written consent, either partition or subdivide the Property or consent to:

(i) the abandonment or termination of the Condominium Project, except for abandonment or termination required by law in the case of substantial destruction by fire or other casualty or in the case of a taking by condemnation or eminent domain;

(ii) any amendment to any provision of the Constituent Documents if the provision is for the

express benefit of Lender;

(iii) termination of professional management and assumption of self-management of the Owners
Association: or

(iv) any action which would have the effect of rendering the public liability insurance coverage maintains (by the Owners Association unacceptable to Lender.

F. Remodies. If Borrower does not pay condominium dues and assessments when due, then Lender may pay them. In amounts disbursed by Lender under this paragraph F shall become additional debt of Borrower secured by the Security Instrument. BALLOON RIDER LOAN NO. 9888597 (CONDITIONAL RIGHT TO REFINANCE)

THIS BALLOON RIDER is made this 3 rd day of May. 1996, and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Deed to Secure Debt (the "Security instrument") of the same date given by the undersigned (the "Borrower") to secure the Borrower's Note to COVENART MORTGAGE CORPORATION

The interest rate stated on the Note is called the "Note Rate." The date of the Note is called the "Note Date." I understand the Lender may transfer the Note, Security Instrument and this Rider. The Lender or anyone who takes the Note, the Security Instrument and this Rider by transfer and who is entitled to receive payments under the Note is called the "Note Holder."

ADDITIONAL COVENANTS. In addition to the covenants and agreements in the Security Instrument, Borrower and Lender further covenant and agree as follows (despite anything to the contrary contained in the Security Instrument or the Note):

1. CONDITIONAL RIGHT TO REFINANCE

At the maturity date of the Note and Security Instrument (the "Maturity Date"), I will be able to obtain a new loan ("New Loan") with a new Maturity Date of the new I. 2026 and with an interest rate equal to the "New Note Rate" determined in accordance with Section 3 below if all the conditions provided in Sections 2 and 5 below are met (the "Conditional Refinancing Option"). If those conditions are not met, I understand that the Note Holder is under no obligation to refinance or modify the Note, or to extend the Maturity Date, and that I will have to repay the Note from my own resources or find a lender willing to lend me the money to repay the Note.

2. CONDITIONS TO OPTION

4. CALCULATING THE NEW PAYMENT AMOUNT

Provided the New Note Rate as calculated in Section 3 above is not greater than 5 percentage points above the Note Rate and all other conditions required in Section 2 above are satisfied, the Note Holder will determine the amount of the monthly payment that will be sufficient to repay in full (a) the unpaid principal, plus (b) accrued but unpaid interest, plus (c) all other sums I will owe under the Note and Security instrument on the Maturity Date (assuming my monthly payments then are current, as required under Section 2 above), over the term of the New Note at the New Note Rate in equal monthly payments.
